Are "white" people more intelligent than "black" people? Are Jews devious and grabby? Intolerance and violence through racism includes slavery, national socialism in Germany, apartheid in South Africa, or the genocides in Rwanda and Bosnia. But racism is not only wrong theologically, it is not only against the dignity of humans, that guarantees their human rights, but newer genetic research also proves that the whole classification into races is without foundation. Biologically speaking all humans belong to one race. E.g., when you need a blood transfusion, you should not look for a blood donor from your 'race', but someone with the same blood group transcending all 'races'.



Thomas Schirrmacher (*1960), Dr. theol. Dr. phil., PhD. ThD, is Chair of the Theological Commission of the World Evangelical Alliance, which represents 600 mio. Christians in 129 countries, professor of ethics at Martin Bucer European Theological Seminary and Research Institutes (Bonn, Zurich, Innsbruck, Prague, Istanbul), as well as professor of the sociology of religion at the State University of the West in Timisoara in Romania and Distinguished Professor of Global Ethics and International Development at William Carey University in Shillong (Meghalaya, India). 

The Bible and Global Social Problems

Thomas Schirrmacher's short, serious book on racism richly illustrates the multifaceted relationship of God's Word to our global social problems. God's Word, as preached by Dr. Schirrmacher, is obviously deep, prophetic social *criticism*, which extends beyond sinful actions to the thoughts and motives in the hearts and minds of people. Not only do we do really horrendous things to other people; our thoughts and theories about people are often reflections of our sin. Even the usual definitions of race flow from the blackness of sin. This needs to be exposed to the light of truth. I hope tears run down your face when you read both about the sin of racism as well as about the sinful theories people have taught.

But our hope is that God's Word, which we all must proclaim, will *contribute* something much more humane and godly to our many societies. Schirrmacher has told some of the great stories about how biblical ideas and the efforts of Christians have both restrained sin (and sinful theories) and in previous centuries even ended much of the slave trade. The biblical message, along with people moved by the biblical message, has made huge contributions in the past history of many cultures. Thank the Lord. But these great stories are not finished! Cry out to God, that this would happen again and again and again through the Body of Christ. Through God's people God's Word can contribute to a more humane future for many. Who knows what God might do through you?! The world needs the salt of God's Word carried by God's people.

This assumes that God's Word can *create* a new community, really a new humanity, that people who are reconciled to God by faith in Christ can also be reconciled to each other, so that different peoples can honestly love each other before God in Christ, by the power of the Holy Spirit. Let the Body of Christ become a place where people from all backgrounds and cultures are really at peace with each other and truly respect the God-given dignity of others, where the sin of racism is truly overcome. What we hope God's Word will contribute to our world should first be created within and among our churches, in our mission agencies, in our schools, in our seminaries, and in our families. Let the Word of God bear fruit among believers!

And it is my deep conviction that this entire discussion of racism and human dignity, with open Bibles in our hands, *correlates* with an anxious cry arising from the bottom of human consciousness: "What is wrong with us, that we do such terrible things? Who are we? Is human dignity real? Can we find courage in the face of such terrible evil? Is there salvation?"

The many quotations from the Bible found in this book, mostly in text boxes set apart from the rest of the book, provide the deepest answers to the questions running through the book. Indeed, one of the reasons to take the Bible so seriously is the way in which it addresses all the deepest cries, needs, and questions in all of life.

So read this book to learn, consider, weep bitterly, and then take action about racism. And along the way, notice the wide-ranging way in which the biblical message addresses all the problems of our broken world.

Preface

It might appear presumptuous to write in a way that 'puts in a nutshell' a phenomenon to which millions of people have fallen victim and which in the course of history has been used to justify genocide, slavery, and war as well as to justify centuries of all sorts of human rights violations. To reduce the terror of National Socialism and the mass execution of Jews and 'gypsies' to a couple of pages in a book, to cover slavery in colonial times and to mention the mass slaughter of Tutsis by Hutus in Rwanda simply does not appear commensurate with the sufferings of the victims of racism.

One could also write numerous pages about the many definitions of 'racism' and 'race' in order to do justice to all the literature on the subject that has been published. On the one hand, myriad opinions arise from missing or unclear basic principles regarding the definition of the terms. On the other hand, since we are dealing with something that has a lot to do with values and emotions, it is difficult to write neutrally about the topic from an academic point of view.

Still, it is only when one wants to grasp and refute racism 'in a nutshell' that the arguments against racism even have a chance. This is due to the fact that if only individuals who make the effort to burrow into the scholarly works of biologists, ethnologists, sociologists, and historians could be assured of refuting racism, then we would be rather helpless against racist propaganda.

I am, however, convinced of the fact that racism is suspect not only on account of its historical consequences but also because it is in opposition to Christian and humanist world views. In fact, everything that recent biology (in particular genetics) and cultural anthropology (including ethnology) have to say on the topic of race completely pulls the rug out from under racism.

The results of modern genetics, behavioral research, archaeology, linguistics, ethnology, and historical scholarship allow only one conclusion that representatives of belief in a Christian view of creation, regardless of whether they are in favor of evolutionary theory or not, have always supported: all of living humanity goes back to a common ancestor in Africa or in an adjacent part of Asia, namely the Middle East. Furthermore, all people are genetically so closely related to each other that one can speak about

a single 'race,' if one speaks of 'race' at all. Racism is to be rejected because all people, in spite of their differences, have the same dignity. While the differences are what distinguish one person from another, they are certainly not what distinguish 'races' from each other.

As a teenager on vacation, I got lost in the port of Glasgow when our tour boat left the port without me on board. Left alone in a run-down area, a young 'black' boy took me in. Thanks to his hospitality and care, I spent the night in the small one-room quarters in which his poor family and their many children lived and slept. Their readiness to help was greater than that of many of the people I knew who had guest rooms. Two days later I was able to reach my parents by telephone. At that time I made a decision to treat people who look and live differently with the same normalcy and friendliness that the family that took me in did, although I was 'white' and 'rich.'

Since my parents had close contacts to the international Evangelical missions movement, church leaders were always coming and going, from Indonesia, Paraguay, and Gambia, as well as from other countries. As a small child I curiously touched the hair of Africans who thereafter gave technically oriented lectures. I grew up aware that people are very different, and yet all of them deserve respect.

Perhaps that was the reason why in addition to theology I enjoyed studying sociology and ethnology, the latter more generally referred to in the USA as cultural anthropology. Meanwhile I have investigated in my second dissertation, which was in cultural anthropology, the nonsensical theories of Hans Naumann and others regarding so-called "folk psychology." In my dissertation entitled *Hitler's War Religion* I investigated the devastating effects that occurred when people began to take a conglomeration of theories from race research and put it into blood-soaked practice.

Note: Since I consider the traditional separation of people according to skin color to be linguistically and *de facto* senseless, as will be documented in detail, I put these designations in single quotation marks whenever I use these designations to refer to people with this prescribed terminology ('black,' 'white').

I. Racism and its Refutation

1. What is Racism?

Definitions of Racism

The term 'racism' emerged in various European languages in the dispute with National Socialism that began at the end of the 1920s. The first definition of racism was formulated in 1940 by the American ethnologist Ruth Benedict: "... the dogma that one ethnic group is condemned by nature to congenital inferiority and another group is destined to congenital superiority. It is the dogma that the hope of civilization depends on eliminating some races and keeping others pure. It is the dogma that one race has carried progress with it throughout human history and can alone ensure future progress."²

What distinguishes this definition from modern definitions is that Benedict does not basically question the existence of human races. Rather, she views racism as a judgment on races that actually exist.

The longest standing definition of racism stems from the French sociologist Albert Memmi: "Racism is the generalized and absolutized judgment of actual or fictitious differences for the advantage of the persecutor and to the detriment of the victim, by which his privileges or his aggressions are justified."

We see here that the differences can after all be of a fictitious nature, but that does not have to be the case. Newer definitions, however, correctly emphasize that the races that racism either elevates or vilifies are created by racism in the first place. Today most researchers involved in the study of racism hold that breaking humanity down into races is itself a racist theory, since race classification practically always serves to exclude people and to justify certain dependencies.⁴

Three newer Definitions of Racism

"To attempt a short formulation, we might say that racism exists when one ethnic group or historical collectivity dominates, excludes, or seeks to eliminate another on the basis of differences that it believes to be hereditary and unalterable."

"Racism is the belief that peoples, via hereditary features, differ in social value and make specific groups superior or inferior to others."

"Racism includes ideologies and forms of practice on the basis of the construction of people groups as ancestral and descendent communities, to which collective features are ascribed and that implicitly or explicitly evaluate and interpret such features as unable to be changed or only able to be changed with difficulty."

We, therefore, find two basic elements in racism:

- 1. the construction of ancestral groupings with alleged common features;
- 2. the evaluation of these groups and differences for the utility of the racists and for the detriment of the victims, thereby legitimizing privileges and aggression.

Therefore, the core of racism, in comparison to other ideologies that are used to oppress people (such as conceptions of class, religion, or disdain for the handicapped) is that what is different in the other person *is based on the individual's biological ancestry and is, therefore, unalterable.* "One can speak of the existence of a racist attitude or ideology if differences that otherwise are seen as ethno-cultural are declared to be innate, indelible, and unalterable." In racism an alleged natural or God-given immutable system of domination serves to justify discrimination, exclusion, oppression, persecution or annihilation of people groups.

Two Strands of Argumentation against Racism

For reasons mentioned, one must argue on two levels against Racism.

Firstly, even proven differences between human races say nothing about the equal dignity everyone has. Skin color, body size, and IQ say nothing about who is valuable and who is not, and they give no one the right to oppress other people.

Secondly, there is no evidence for the assumption that there are such biological differences between distinguishable races in the first place. It is not possible to assign people's appearance or behavior to biological ancestral groups with hereditarily determined similarities, and it is not possible to map any external features to their behavior or their character.

The second point should actually suffice. This is due to the fact that if there are no human 'races,' racism is always false. Why? Because it is impossible. And yet, racism, unfortunately, repeatedly constructs new 'races,' such that the first level argumentation basically has to be repeatedly brought forth.

While the scientific evidence for the fact that there are no races increases with every decade, up until the present it is common to utilize ancient and frequently refuted divisions according to skin color in the absence of an alternative. Leading encyclopedias explain under the 'racism' heading that there is no such thing as races, only to then nonchalantly continue to refer to the differentiation under the 'race' heading or the headings of these individual 'races.'

Excursus: With God there is no Favoritism!

The widely attested statement that when we make decisions we should show "no partiality" (Deuteronomy 1:17; II Chronicles 19:7; Proverbs 18:5; 24:23; Job 13:10; Ephesians 6:9; Colossians 3:25), because God himself knows no partiality (e.g., Deuteronomy 10:17-18), means that only wicked judges show partiality (Isaiah 3:9). For that purpose James writes: "If you really keep the royal law found in Scripture, 'Love your neighbor as yourself,' you are doing right. But if you show favoritism, you sin and are convicted by the law as lawbreakers . . . Speak and act as those who are going to be judged by the law that gives freedom . . . (James 2:8-12).

There are numerous Forms of Racism

Racism is found in everyday life as well as in politics and scholarship. It ranges from prejudices and discrimination, slavery and racial segregation all the way to pogroms, forced displacement, ethnic cleansing, and genocide. The most extreme form up until now has been the industrial destruction of the Jews under the Third Reich.

Eight different historical and present day Examples of Racism

Germany and Europe: Exhibitions of People in Zoos. The heyday of exhibiting people occurred between 1870 and 1940. This involved exhibiting non-European peoples in zoos, in circuses, and in special exhibitions.

During this time there were over 300 such groups in Germany, which consisted of groups of family size all the way up to groups of 50 people. What was well known were the areas in the Hagenbeck Zoo in Hamburg for Beduins, Somalians, or Eskimos. The true living conditions of these peoples were not shown. Rather, the penchant was for the clichés the public wanted to see.

Uganda: The forced Displacement of Indians. In 1972 the dictatorial government, with the support of the black African population, began to expel 80,000 Indians. Indians made up 1% of the population, but they accounted for 50% of the doctors and 80% of the business people in the country.

Soviet Union: Contempt for "Blacks." In the 1970's, at the expense of the Soviet Union, black Africans trained for the war of liberation in South Africa in camps near Moscow. When they were on leave and approached and spoke to Russian women, they were beaten up or arrested by the police.

South Africa: Racial Segregation. From 1948-1990 'whites' were not allowed to marry 'blacks,' 'Indians' (Asians, namely 'colored') or people of mixed race. The four groups mentioned had to live in separate housing complexes, go to separate schools and universities, use separate hospitals, means of transportation, toilets, and beaches, whereby the facilities for the 'whites' were naturally always better equipped. Only 4 million 'whites' had the right to vote, while 18 million blacks and others were left without the right to vote.

Rwanda: Tutsi Genocide. Between April and July 1994 somewhere between approximately 800,000 and 1 million people were killed within 100 days by members of the army, the police, and the civil population from within the Hutu majority. This action killed 75% of the Tutsis living in Rwanda.

USA: Was Adam 'white' or 'black'? Racist militias in the USA are convinced that Adam and Eve were white and only whites descend from them. Elijah Mohammed, the founder of the Nation of Islam, which was the American organization of 'Black Islam,' represented the idea that Allah created Adam black. Both groups thought that the other races emerged from commingling with animals.

Saudi Arabia: Exploitation of Filipinos. It is primarily Filipinos, either Muslim or Catholic, who do the dirty work for the many rich Saudis. They are in part housed and treated inhumanely, and their rights are handled in a bad way since they can be deported at any time. Additionally, Filipinos are

often prepared to accept each and every job, because at home large families live off of the money they transfer back home.

Germany: the NDP (National Democratic Party of Germany) on Africa. "In actuality . . . all aid to developing countries is a giant swindle! Nothing can 'develop' in Africa that would equate to what one has in European terms. The truth is that everything that is found on the Black Continent with respect to civilization was created by whites. And there, where white men are not or no longer found, nothing works – things are that simple . . . The tax monies for foreign aid end up being bribes in the pockets of Negro chieftains . . ." "Whoever indiscriminately speaks about 'people' and does not look at Germans should also not be shocked if he sees poverty stricken German retirees fishing for returnable bottles in garbage cans, while behind him stands a large oriental family fed by the state or an arrogant, affluent Negro stalking around! For whomever these are just undifferentiated 'people,' such a person is no longer capable of recognizing the screaming injustice of this everyday scene in the 'multi-colored Federal Republic of Germany'". ¹⁰

Thereby, it is worth noting that racism is older than the term racism itself. It is older than every 'racial doctrine' and always occurs when people declare other groups to be a biologically common group that is subordinate, less civilized, lazier, or more dangerous. For this reason the United Nations defines "race discrimination" in the International Convention on the Elimination of All Forms of Racial Discrimination of 1965 as "any distinction, exclusion, restriction or preference based on race, color, descent, or national or ethnic origin which has the purpose or effect of nullifying or impairing the recognition, enjoyment or exercise, on an equal footing, of human rights and fundamental freedoms in the political, economic, social, cultural or any other field of public life."

It should be mentioned in addition that there is not only one racism. Rather, there are other respective forms that it takes on *according to who incites it and against whom it is directed*. Racist movements always have a national or cultural characteristic, and they are strongly differentiated according to which group uses racism to fight which another group. "... wherever we find racism, we discover that it is historically specific, ac-

cording to the specific era, according to the particular culture, and according to the distinct societal form in which it arises. These respective specific differences need to be analyzed. When we speak about a concrete societal reality, we should, therefore, speak about racisms and not racism."¹²

The major and minor Racism of the 'Races'

The most basic form of racism acts on the assumption of major races of humanity and scorns and battles against 'blacks' (the most widespread type of racism throughout history and into the present), 'reds' (e.g., in Brazil), 'yellows' (e.g., in Uganda) and 'whites' (e.g., in Zimbabwe).

However, under racism one also includes the oppression of each small ethnic group or of whichever groups that the racist defines as belonging together.

If contempt by a 'major race' is already baseless, then it applies all the more because as a result of history most peoples are already mixed breeds. It would be saying too much to maintain that one could, for instance, biologically distinguish between Teutons and Jews, German and French, Catholic Irish and Protestant British from Northern Ireland, or Walloons and Flemish from Belgium, to just look at a few European examples.

If I am surveying everything correctly, there are three types of racism which internationally are the most widespread and which have over the centuries been able to be pursued. One stands for 'major' racism, and two stand for the 'minor type:

The three most widespread Types of Racism that are also international

The defamation and fight against or oppression of

- 1. **'Blacks**' (or of people who have a darker skin color than oneself) they are allegedly dumb, barbarian and uncivilized;
- 2. **Jews** they are allegedly devious, greedy, and domineering;
- 3. 'Gypsies' also called 'Roma,' they are allegedly asocial and thievish.

Other Terms

In the racial setting, there are often related terms that are used. They are to be outlined in the following.

Everyday racism: Racism in everyday situations. The individual taking the racist action cannot offer an ideological justification, since the idea of the superiority of his own group is of such a second nature that the person takes the discrimination that follows from it to be normal and logical or not even noticed any longer.

Anti-Semitism: Hatred for Jews (and not for Semites in general), see pp. 70-71.

Anti-Zionism: Hatred for the modern Jewish state of Israel in Palestine. It is a special form of anti-Semitism, see p. 65 and 71.

Anti-Gypsyism: a technical term based on 'anti-Semitism' for hostility towards gypsies, see pp. 69-70.

Hatred of Foreigners: "Hatred of foreigners is first of all directed against the status of foreign nationality. Over the course of time this characteristic of being a non-native is intensified by ascribing negative characteristics that are possibly noticeable over generations in the people concerned. While racism in the narrower, biologically argued sense is based on the alleged inalterable ascription of features, this attitude can weaken with time. Where formerly certain people and groups were looked upon as foreign, they lose their stigma and are then perceived as 'accepted' and 'local.' ¹³

Ethnocentrism: This is a fixation on one's own cultural context, which means exchanging the worldview one has of one's own culture with reality. In contrast to racism, ethnocentrism desires or forces the assimilation of others.

Xenophobia: a negative attitude and behavior against people and groups and outsiders of all types who are alien and different. Xenophobes hate the language, culture, clothing, and nationalities of others. Racism, on the other hand, hates the 'race' and 'descent,' whereby both naturally can go hand in hand. They mostly do, but it does not have to be the case.

Acts 17:26-28a: "From one man he made every nation of men, that they should inhabit the whole earth; and he determined the times set for them and the exact places where they should live. God did this so that men would seek him and perhaps reach out for him and find him, though he is not far from each one of us. 'For in him we live and move and have our being.'"

Genesis 1:26-28: "Then God said, 'Let us make man in our image, in our likeness, . . . So God created man in his own image, in the image of God he created him; male and female he created them. God blessed them and said to them, 'Be fruitful and increase in number; fill the earth . . .""

Genesis 5:1-2: "This is the written account of Adam's line. When God created man, he made him in the likeness of God. He created them male and female and blessed them. And when they were created, he called them 'man."

His purpose was to create in himself one new man out of the two, thus making peace, and in this one body to reconcile both of them to God through the cross, by which he put to death their hostility. He came and preached peace to you who were far away and peace to those who were near. For through him we both have access to the Father by one Spirit."

2. There are no human Races

'Race' in Biology

How does biology nowadays use the term 'race'? The answer is clear: 'race' is now only used for plants that are raised by man as well as for productive livestock and pets. In these cases man breeds for particular characteristics and prevents the mixing of races by controlling breeding. This would be impossible to do with people. For wild animals and wild plants the term 'race' is practically no longer used.

In order to distinguish between biological species – which is clearly defined by the limitations of cross breeding – the term conspecies or subspecies gradually arose for plant 'forms' and 'varieties,' which, however, were for a long time not as clearly set down as the species and the hierarchical terms that were established with them.

All the people in the world can be 'crossed' with each other. What that means is that principally every man who is potent can have a child with every woman capable of bearing children. This is an unmistakable indication that in the case of people we are speaking of one and the same species. The United Nations has aptly laid this down legally, which by the way is an astonishing recovery of the Christian tradition: "All human beings belong to a single species and are descended from a common stock. They are born equal in dignity and rights and all form an integral part of humanity". 14 In the Lexikon der Biologie (Encyclopedia of Biology) one reads the following: "In the study of race within anthropology the term 'race' was used for the classification of people groups at various levels below the species homo sapiens, whereby only the so-called geographic major races (Caucasian, Mongoloid, Negroid) could have corresponded to the status of sub-species. Different populations and molecular-genetic investigations indicate, however, that the division of mankind into 'races' has no genetic basis."15

Biology Professor Ulrich Kattmann from Oldenburg has represented the view in numerous publications that the term race in biology has generally become as obsolete as it has with reference to people. "The critique against the concept of races of mankind is often met with misunderstanding and resistance from the biological side, since it is thought that the task of the

term race as a general biological principle is infringed upon: race classification is a common procedure in all of biology . . . Man has no exceptional position and is, therefore, to be treated as all other animal species. The concept of race is necessary for an understanding of animal species. The concept of race is required for an understanding of evolution . . . The author admits that he himself thought this way for a long time . . . Detailed analysis shows, however, that none of the arguments for holding to a concept of races among mankind is biologically valid. First of all, it has been observed that the term 'race' in zoology has to the greatest extent become obsolete and is only extensively used by anthropologists and household pet researchers . . . The sole object range in which 'race' is used as a technical term has to do with varieties of household pets . . . natural populations are, however, genetically manifold and in no way are they comparable to household differentiated populations that are geographically clearly distinguished and are zoologically designated as sub-species. The subdivision of species into sub-species or even more precise categories is by no means an obligatory biological principle. The zoological classification is only mandatory at the species level: Every procreating organism that requires two parents necessarily belongs to a biological species, which is defined as a reproductive community . . . With people the diversity within and between the populations is so complex that it is inexpedient to further subdivide this species . . . The concept of race is simply unfit to capture the genetic differences of people in their individual and geographic diversity." ¹⁶

Despite great efforts, Races have not been found

The term 'race' is one of the most successful ideas of modernity. Prior to 1400 it was unknown in all its components, and in the 18th century it developed gradually. From that time onward, and up until the middle of the 20th century, there was hardly anyone who doubted the existence of clearly distinguishable major human races, although there had never been a half-way acknowledged division of such races.

From 1850 until about 1950, one can speak of the heyday of anthropological race measurement techniques. Skin color tables, bone measurements, body size, cranial measurements, and numeric ratios were the order of the day. There was little that was not measured and categorized with great effort throughout the entire world. If there ever had been the possibility of dividing humanity into manageable and distinguishable races, it would have had to have been found.

This is, however, the way in which innumerable race classification theories came about, and the work associated with it was shoddily conducted. This was demonstrated primarily by Stephen Jay Gould in his classic text *The Mismeasure of Man*. The shoddiness of the work conducted meant that the data was bent to shape and interpreted until the desired result was achieved. In the beginning it was the size of the brain that was taken as the indication of races and their value. When it, however, became clear that Eskimos, Laplanders, Malays, and Tartars had the largest brains, this feature was dropped.¹⁷ It had anyway been known for a long time that the size of the brain and intelligence are not automatically associated, with the result that good excuses were able to be made about the data.

There was never a generally accepted division of people into races. Rather, there were always new and changing suggestions that many researchers even rescinded within their own lifetimes as scientists. This also applies to the Third Reich, in which completely contradictory race classifications competed with each other.

This epoch of measurement techniques moved into a period of critique. Its first representatives would have been able to pull the foundation out from under racism after World War I had one just listened to them. The most important elements of critique were:

- 1. Hereditary characteristics and environmental characteristics cannot be adequately distinguished from each other. Before measurement results can be compared, it must be proven that they are hereditary and remain constant over many generations.
- 2. Measurements feign a juxtaposition of races, although the world population demonstrates a sliding continuum of different population mixes.
- 3. Every researcher establishes his own typology.
- 4. The typologies are not substantiated in field research conducted on site. It is so simple to place a photograph of a typical 'German' next to the photograph of a typical 'Russian' in an atlas, but it is difficult to find *the* German in Germany and *the* Russian in Russia. It is simply the case that due to thousands of years of trading relationships, migrations, streams of refugees, wars and marriages out of love, we are mixed breeds across all cultures.

5. Awareness has increased more and more that the differences people have in language, culture, or religion cannot be attached to biological settings or genes. Rather, each one of them has a long cultural history, into which each individual gradually grows through socialization. "The classical argumentation of biological determinists fails because all characteristics, which they call upon to distinguish between groups, are normally the products of cultural development." ¹⁹

When for instance all the children in a village in Africa play together in the street, grow up, and learn from each other with little school education, they will tend to be characterized by the acceptance of knowledge from those who are bigger and stronger. This is due to the fact that it is always the older and stronger children who set the tone. As a result of this, the child will also be shaped by learning via classroom teaching and reciting what he or she has learned. If the same child from the same village were to grow up with parents who are attuned to well structured formal education, and the child experiences a good classroom education, he would, as is common in Germany, no longer be raised by older children and determined by that situation. Rather, he would be shaped early by his relationship with adults, who want him to grow into a situation where he is self-reliant. The result is the same as in Germany. And vice versa: a German child, who as a baby is adopted in a poor African village, would develop the same learning behavior as an African child there.

Excursus: The Senselessness of Hitler's Thoughts on Race

Since race played such a central role in Hitler's thinking,²⁰ it is amazing that Hitler had such a vague definition of race, and he practically never addressed in any detail the question of race or race classification. He never admitted that any special school of racial thought was correct, and just as the entire racial movement, he did not distinguish between terms such as 'German,' 'Germanic,' 'Aryan,' or 'Nordic,' or between 'race,' 'folk,' 'fatherland,' or 'blood,' and he did not even once mention the races found in Hans F. K. Günther's quasi-official racial doctrines. What was at stake was to put "the scientific insights of racial doctrine" into practice. When it came to concrete supporting documents, it was Hitler's own observations

that allowed him to recognize who belonged to which race and which race brought forth which culture.

When Hitler, for instance, wrote: "The racially pure Teuton who has remained unmixed on the American continent has risen up to become the ruler of the same," it can hardly be deciphered whether he means the Teutons in America who are the descendents of Germans, Northern Europeans, European immigrants, or the white race in general. Hitler himself had primarily propagated the term 'Aryan' through his use of the word in *Mein Kampf*. It underscores what was just said to mention that in 1935 the government of the Reich had attempted unsuccessfully to replace 'Aryan' by 'German-blooded.'

Lawrence Birken has correctly pointed out that these generally persistent statements made in Hitler's racial doctrine were the reason why completely varying racial doctrines among National Socialists could all find a reference point in Hitler.²¹

In National Socialism and in its literature completely contradictory concepts of race competed with each other. Were one to follow Günther's racial types, the question would arise as to where the actual Nordic race is even supposed to be living. The Nationalistic Socialistic educational theoretician Ernst Krieg was even of the opinion that race is rather acquired and conveyed by folk discipline. Next to this are many inconsistencies: if it had to do with recognizing external racial features, then it would be the case that Danes, Norwegians, and members of hostile nations had a higher racial value.

Hitler did not attach race to lineage and appearance as, for instance, Himmler did. Rather, Hitler attached race to leadership abilities demonstrated in practice. Goebbels also did this. Race was recognized in proving oneself, for instance in war or in leadership tasks, but not in outward appearance. At this point, Hitler's teaching of great character played a central role as the highest display of race. This is how Hitler's statement was reported on in 1942: "The racial struggle does not have to erupt if people are not chosen according to their external appearance but rather according to their ability to prove themselves. Appearance and nature often take separate paths. One can make a selection according to external appearances or one can make it, as the party does, according to fitness for life." Hitler's racial understanding is basically no longer a biological concept of race. Hitler recognized races and higher order value within a race on the basis of

how people responded to his 'idea' and whether they were ready to fight, that is to say, put their worldview into practice in a death defying manner!

It is for this reason that Hitler also was in favor of making a selection among siblings and was rather generous to recognize Aryan features in half-Jews or quarter-Jews. Precisely this aspect was a strong indicator that Hitler took people's racial affiliation into account and that he could not and did not want to view them according to some scientific approach. Finally, it is for this reason that Hitler was able to place members of other races higher than Germans. He did this, for instance, in 1928 when he said: "An Anatolian farmer has more value than a German man of letters." And he was convinced that the "Japanese, Chinese and Islamic peoples are always closer to us" than "the French."

'Races' have been refuted by Genetics

Recent genetic investigations from around the world have brought to light the astonishing genetic similarity of all people, as well as, however, the striking commingling of the gene pool. At the DNA level all people are of *one* race, not of several. "The results of modern genetics have unobjectionably demonstrated that there are no different human races, and rather that there is only one species of mankind." The genetic differences between people within one 'race' are on average greater than the genetic differences between different 'races.' "Modern DNA analysis, which has determined that genes do not carry any weight at all and yet code the visible differences, supports the viewpoint of many experts (in particular ethnologists and sociologists) that the term 'race' no longer serves a scientific purpose outside of biology and for that reason should be avoided." 23

"Racists are still convinced that biological traits also determine differences in behavior, character, temperament, and with respect to intelligence. Modern genetic research demonstrates the opposite. Such research shows that cultural differences between groups cannot have biological causes. It is now known that human behavior, just as intelligence, is extremely strongly shaped by varying social conditions and significantly the product of culture, which is to say that it is learned."²⁴

The most prominent human geneticist in the world, Luigi Cavalli-Sforza, who conducts research in the United States and in Italy and who has domi-

nated the field for 30 years, has submitted a comprehensive gene atlas, in which he analyzed people from all regions of the world on the basis of numerous genetic indicators. He demonstrates that external differences such as skin color and hair color, hair structure and nasal shapes are only adaptations to different climate and nutritional conditions, and that they are determined by a smallish sub-group of genes. Viewed genetically, in principle any group all the way down to the residents of a small village can be differentiated from other people. This means that among humans the genetic diversity is so large that it is zoologically inappropriate to take people as a biological species and subdivide them. This argument was used in 1871 by none other than Charles Darwin, who had no knowledge of modern genetics, in his book about the descent of man.

Statistically, the genetic difference between randomly chosen Africans and Europeans is only 15% greater than that between people from one and the same village.

A new study from 2008 takes the discussion further: "Just how rich in diversity is the human genome? And where did our direct ancestors live? Precisely these questions can now be answered with a global map of human genetic variation. With more exactness than ever before, scientists can now reconstruct via genetic variation human migratory movements and the genetic differences within individual people groups. The study, which has been published in the technical journal "Nature," is based on a combination of different methods for making genetic comparisons. "Scientists . . . sifted through the DNA of 485 people from 29 different populations and five continents and compared three types of genetic variation . . . 'Now that we possess the technology to examine thousands and even hundreds of thousands of genetic markers, we can conclude in better detail than ever before what the relationships are between human populations and what the former migrations were.' . . . People of African descent are genetically the most differentiated, followed by inhabitants of the Near East, Asians, and Europeans. The smallest range of variation was discovered by researchers to be among the original inhabitants of the Americas."²⁵

The Example of Blood Groups

Blood group systems have been globally researched for a considerable length of time. This also applies to the way blood group systems hereditarily behave. Blood group systems are found throughout all alleged races and

peoples, but only their percentage of distribution is varied. This applies to "blood groups" and to "rhesus factors," but it also applies to unknown blood characteristics such as the HLA group of antigens (human leucocyte antigen), which play a role in organ transplants. As far as the rhesus factor or HLA group antigens are concerned, Europeans and Africans are closest to each other and together differentiate themselves from Asians, Eskimos, and Indians.

For this reason every person can have blood donated for him or her by anyone who has a matching blood group, regardless of whether that person is a European, Asian, or Latin American. A so-called 'universal donor' with blood type 0 (Bloodtype 0, rhesus negative) can give blood to any person, regardless of ethnicity!

The Genetics of the 'white' Race

Genetic investigations confirm what linguistic science in a similar manner has always known. That is the fact that Indians are not related to other Asians, but rather to Europeans. It is for this reason that one speaks of Indo-Europeans. What is new, however, is the realization that this is also the case for Indians whose skin color is significantly darker than that of Europeans.

Genetic research shows that also in the case of blond Northern Europeans there are, genetically speaking, many ancestors detectable from Asia. These allegedly remote peoples are also mixed breeds consisting of natives and those who are non-natives and have immigrated from afar.

3. 'Blacks,' 'Yellows,' 'Reds,' 'Whites'

Three major Races of Humanity?

If there ever was a hard core at all regarding the division of human races, then it is the division into the three 'races' of Negroids ('blacks'), Mongoloids ('yellows,' Asians) and Caucasians ('whites'), whereby, however, the assignments and sub-assignments, for instance, of Indians, Eskimos, or Australian Aborigines remained and remains completely unclear.

This division actually follows only three external features: skin color, hair coat, and the form of the nose. Additionally it is not thinkable with the simultaneous assignment to the continents of Africa, Asia, Europe, and America.

These differences, however, only roughly apply. There are 'Caucasians' who have darker skin color than the lightest 'blacks,' and that indeed after the most disparate divisions by various researchers. As far as skin color is concerned, Asians are *de facto* not able to be differentiated from Europeans, because their spectrum from light to darker corresponds approximately to the spectrum found in Europeans. The 'yellow' skin color of Mongoloids, in contrast, is a pure invention from the end of the 18th century, for which a true justification was never supplied.

According to the classical subdivision, the Ainu of Japan – often also called 'Caucasians' or 'Indo-Europeans' – belong to the 'white' race as do the Drawid of India, the Tamils and Singhalese of Sri Lanka, Persians, Arabs along with Berbers, old Egyptians (Coptics) and Moors, Romani, Teutons and Slavs including Russians and Poles, to name just the most important peoples or families of people. And these people should be so closely related with each other that one can distinguish between Asians ('yellows') and Africans ('blacks')'?

The 1892 Brockhaus Encyclopedia also includes as Caucasians the Hamites along with Berbers, old Egyptians and East Africans, Semites along with Hebrews, Chaldeans, Canaanites, Assyrians, Babylonians, Arabs, and finally the Aryans along with Indians, Medes, Persians, Afghanis, Curds, Armenians, etc. "The black-haired, dark-eyed type, with a skin color including almost all shades up to truly black, also belongs to this group. They include the majority of the inhabitants of Southern Europe, North Africa, Southwest Asia." Could, therefore, by all appearances 'blacks,' really be Caucasians and form one race with Middle Europeans?

Even the leading race researcher of the Third Reich, in his 1982 newly republished and sinister work *The Nordic Race among the Indo-Germanic people of Asia*, ²⁶ counts, among others, the following peoples as Indo-Germanic with a Nordic element: Indians, Scythians, Javanese, Belutshis, Afghanis, Persians, Tajiks, Saks and Armenians.

Furthermore, how much sense does the expression 'colored' make, if the 'white' race itself encompasses an enormous spectrum from light to dark? Is it not just imaginary to say that 'we' are 'white' and the others are 'colored'? Is it not just always haphazardly connected with an implication that allows an assessment to be derived on the basis of color?

It is only known to a few that he speaks of a much greater spectrum of peoples when he speaks of 'blacks' and 'yellows.' 'Black' is quite obviously used for very different peoples, who aside from skin color mostly have nothing to do with each other and whose skin color lightness additionally exhibits a broad spectrum.




Illustration 1: A traditional map of the races of the 19. century (from the leading German encyclopedia 'Meyers')²⁷

Why should one classify in this manner at all? When a census is conducted in the USA, information is also collected as to whether a person is white, black, native American, or Hispanic. Apart from the many descendants from mixed marriages and from the fact that many immigrants do not even know themselves precisely who their ancestors were, the latter category shows how senseless this categorization is. This is due to the fact that Hispanics only have a common language, but otherwise originate from completely different countries, peoples, and backgrounds.

The American President Barack Hussein Obama is the offspring of a Kenyan student from the Kenyan Luo and a 'white' American. According to his ancestry, he has nothing to do with most of the 'blacks' in the USA, who are descendants brought over from diverse African tribes many generations ago. But since his skin color is not 'white,' he is viewed as a 'black' politician. Such a classification has no real informational value.

Body Size

Let us take body size as an example, which in all people with little exception lies between 120 and 200 cm. There is a people in the Congo that has the smallest group mean, and that is 142 cm. The highest mean for a people is in the Upper Nile in Sudan, where the value is 185 cm. It is not coincidental that both people groups belong to 'blacks.' The Masai in East Africa are known for their size, which one traces back to the fact that they almost exclusively live off of animal products. Tall Ethiopians, who win at the Olympics, are known around the world. At the same time the fact that the shortest people on earth are Africans was taken as a sign that they lag developmentally. On account of this, there is no question that body height is not suited for racially dividing people, but that changed nothing of the fact that for 150 years one was of the opinion that body height could be so used .

Throughout the centuries, average body height in Central Europe fluctuated significantly, primarily due to living conditions and the availability of food. The low point came in the 17th and 18th centuries, when the average was 163 cm for men. The value today for 18-35 year old German men is 180 cm, and for women the value is 167 cm. Much research has shown that the average body height found in a region is a direct indicator of living conditions.²⁸ As a result, the population in North Korea since World War II

has stagnated at an average of 159 cm, and in South Korea, on the other hand, the number has increased to 165 cm. All of this has little to do with 'race.'

Doctrines about Skin Color and how they developed

All attempts to make a true classification of human skin color and to assign skin color to certain ethnicities have to be viewed as unsuccessful efforts. Indeed, the rate of pigmentation that determines skin color, above all the melanin, is genetically conditioned. But it varies within all ethnicities and all the more in greater geographic regions. The lightest Asians are as light as the lightest Europeans, and the darkest 'Caucasians' ('whites') – regardless of which of the many early race divisions one prefers – are as dark as almost all Asians and surely exceed more than half of the Africans in this respect.

By the way: Most researchers assume today that the darker skin tone is the more historic one and that the lighter European and Asian skin tones developed independently of each other.

Historians have shown long ago that doctrines about skin color, in the form they have been commonly known since the time of Carl von Linné (1707-1778), are not based on research or biological reality, but were rather developed to explain alleged cultural superiority.²⁹

Walter Demel has examined the initial sources of Europeans traveling to China, who, along with Marco Polo, held the Chinese to be 'white.' It was not until the last third of the 18th century that the Chinese were seen as 'pale yellow' or 'wheaten,' what is ultimately parallel to 'reds' and 'yellows.' This has little to do with any physical realities, but it has a lot to do with European pigeonholing. It is not by accident that the first person who spoke about a 'yellow' race was the philosopher Immanuel Kant, who never left Königsberg and presumably never saw an Asian during his life. Yellow symbolized the Middle Kingdom and emperor of China. But skin does not become yellow just from that, and this also applies to the many Asian peoples such as the Japanese, Koreans or Thais. 'Yellows' are on the whole *de facto* just as light or dark as Europeans. Due to their advanced civilizations one does not want to designate them as 'brown' or 'black,' and they were also not able to be called 'white,' so 'yellow' was a good compromise.

That 'reds' have their ornamental painting to thank for their symbolized color and not their skin color, has been shown long ago. It is a self serving declaration to say that on the whole the entire Indian genre only used land but neither settled nor occupied it, just because they hunted while freely wandering over the prairie. This was not even the case with the bulk of Indians, but it made it easier for American settlers to take the land from the Indians. This is the basis upon which the highest court in the USA decided that Indians only utilized their land for short periods of time in order to hunt wild animals but never saw the land as their property. Almost all Indians were *de facto* settled and lived in villages, alternating in winter and summer between permanent tent settlements. Additionally, most of them lived from crop farming and not from hunting roaming animals.

Excursus: Ethiopians ("People of Cush") in the Old and New Testaments

The Old Testament assumes that all people can and will pray to God. It is a matter of course that African people are also included: "Envoys will come from Egypt; Cush will submit herself to God" (Psalm 68:31); I will record Rahab and Babylon among those who acknowledge me – Philistia too, and Tyre, along with Cush . . ." (Psalm 87:4).

What Luther and others rendered *Mohren*, the Old Testament names 'Cush,' i.e., Nubia (today predominantly in Sudan) or 'Ethiopians.' Conversely, Amos 9:7 clarifies that God treated Israelites, Egyptians, and Ethiopians equally in judgment.

Racism Racism

In church history the fact that the first non-Jew to convert to following Jesus Christ was a 'Black' Ethiopian looms large (Acts 8:27-39). He was namely the finance minister of the Ethiopian queen (Acts 8:27). In Ethiopia, in which many 'black' Jews lived (and live), the first Christian kingdom in history soon emerged!

Whether on Pentecost the pilgrims from Egypt and Libya (Acts 2:9-11) were dark skinned or not is not completely clear. However, in church history it is taken to be the case. Among the 16 named native regions, it is indeed hardly likely that there were 'white' pilgrims from Europe.

While not reported in the New Testament itself, it was taken early on as agreed that there were *three* wise men from the orient who were the first to worship Jesus, one of whom was 'black' (who is most often ascribed the name "Caspar"). He is found in practically all representations of Christian art, in which the three wise men (kings) appear before the child in the crib. The depiction of a black person worshipping Christ has made a positive impression on theological thought for a long time.

How do stereotypical Images of Differences and Diversity come into Existence?

Criteria, on the basis of which races are defined, can be arbitrarily chosen. A member of the public decides today who belongs to a 'race' based on criteria the individual himself lays down or owing to criteria he or she finds prescribed by education, the media, or the political realm, independent of any scientific criteria.³⁰

For instance, why is it that we sense that Chinese or Ukrainians look so different? The appearance of a person is not only determined by biological circumstances, but rather also from that individual's culture, i.e., the entirety of what is learned and accepted from one's environment. From the time we are small we learn and mimic gestures, a way of walking, and the language of our environment. Hair styles, make-up, and clothing go one step further. From the time we are small we also learn to differentiate between the faces and people in our environment.

If we suddenly meet people who do not fit into our schema, they appear to us to be completely different. Furthermore, if we meet several people from a people group that is unknown to us, they, surprisingly, appear to us

to all be the same or similar. As Germans we have never learned to differentiate between Japanese, although Japanese, among themselves, are naturally as different as Germans. Should the occasion arise, we would not be able to give the police a precise description. Rather, we would only be able to say: "He somehow looked like an Asian." If we were to live a long time in Japan, we would be able to differentiate between people there and describe them.

I have a good friend who is 'black' and who grew up in Switzerland. His parents had good career positions in Switzerland. He speaks Swiss German, behaves like a Swiss German, and looks like one, too – except for his skin color. In the twilight every Swiss takes him to be a Swiss, because he moves 'correctly,' etc., and on the telephone sounds in any case Swiss. It is only in the light that a certain bewilderment arises.

At certain times in the Islamic world it was Arabs, Persians, and Turks who were respectively the ruling 'people,' and as a result they are until the present hostile towards each other. Which European can even assign people from the three Islamic groups, Arabs, Persians, and Turks to one people group if they are groomed and dressed the same? The threatening appearance that many Europeans sense when they see oriental people is only experienced when such people have certain typical features, for example a strong, dark beard. Less conspicuously dressed, groomed and without hearing the language, a European cannot say whether the person before him is a dark Italian or an Arab from Afghanistan.

Dehumanization and Cannibalism

The 'dehumanization' of other 'races' and groups is also found in the repertoire of racism. Hitler was not the first to declare others – in his case the Jews – to be bacteria, fungus, ape-like and closer to animals than to people. Via numerous depictions, attempts were made to show that Jews resembled apes. This was an approach that had been tried most intensively on 'Negros' for centuries.³¹ Typically no one made reference to the fact that 'whites' have thin lips in common with chimpanzees . . .




Illustration 3: With gimmicks like this the 19th century tried to prove similarities between apes and Africans (from the academic book 'Types of Mankind', 1845)³³

For centuries Japanese considered Europeans to be barbarian and animal-like, because in their opinion they had so much hair and had so much to do with dogs. The Chinese thought that Europeans were close to apes and considered them albinos, who through some unnatural way or through demons had lost their color. The way Europeans sweated made them threatening. Frank Böckelmann³⁴ has exhaustively shown how Japanese, Chinese, and West Africans viewed Europeans, but also how Asians saw 'blacks,' for instance. Insofar as racist disdain is concerned, no one is really behind anyone else. These points of view are to us preposterous and without any merit, but the European viewpoint was no less groundless.

In a study I conducted on 'cannibalism,'³⁵ I reported in detail on the ethnological discussion as to whether cannibalism had ever been part of a culture or whether the New York anthropology professor William Arens is correct with his thesis that there is no such evidence about any nation that would ever hold up in court. Even among researchers who hold this position to be excessive, it is beyond question that in the far majority of cases of cannibalism which have been reported throughout history, they have been without witnesses and only a fraction of the reports were and are able to be verified. It is rather the case that 'cannibalism' is a favorite allegation against strangers that regularly served Europeans well in justifying the exploitation of Indians or Africans. The first Christians were likewise suspected of cannibalism by the Romans as were the Irish by the Greek historian Strabon or the Scythians by his predecessor Herodotus.

David Livingstone, anthropologist, researcher on Africa, and distinguished missionary came to a similar result regarding Africa in 1874. He traveled through large parts of Africa, among other locations, on a search for evidence of cannibalism. He was astonished to find that there were no pieces of evidence. However, he did ascertain that almost all blacks were convinced that whites were man-eaters, which was an accusation that the first explorers of the Gambia River had to address as early as 1455.

4. IQ Racism

Are 'Whites' more intelligent than 'Blacks'?

Since in the meantime all attempts to differentiate among races according to some type of measurement have failed, a newer, allegedly exact measurement method to differentiate between the races became popular. This is the series test used to measure intelligent quotients (IQ). "What craniometry (the measurement of the cranium) was for the 19th century, intelligence tests have become for the 20th century..." The IQ appears to be the last remaining reserve of those who are of the opinion that the 'white race' (if not Europeans alone) is superior. Why was it not the Japanese or the Jews (who, however, are 'whites') who colonized the world – as their average IQ on the basis of the same investigations in the USA are higher? And why have Europeans or Americans not offered the Japanese and the Jews global sovereignty but rather are hostile to them?

The Bell Curve is a controversially-discussed work by two Harvard professors, Charles Murray and Richard Herrnstein, and represents above all the thesis that black Americans achieve IQ test results that are on average about 15 points lower than whites. They maintain that this difference is at least 60% genetically conditioned and for this reason IQ cannot be raised through education. The following can be said about this:

- 1. Supposing that the results are beyond critique, the answer to the question of how the differences are explained (genetically, 'racially' or, in fact, through social and cultural conditions) is as open as it has always been. This is due to the fact that because researchers are not able to prove there is an intelligence gene. Should the fact that in the USA 40% of all 'blacks,' but only 5% of 'white' children live in poverty play no role?
- 2. Whether the members of the various skin color groups would differ from each other in terms of IQ if they grew up under almost the same social conditions has not been investigated. Some other studies tell a different story. For instance, middle class Canadian black Africans score 20 points higher on IQ tests than other participants with the same African ancestry.
- 3. What is addressed is an overall average. With all groups there is an entire distribution all the way up to the extremely gifted. Methods re-

lating to averages are very unreliable, due to the fact that with all groups the same range is found.

Are the measurements themselves reliable?

For numerous reasons they cannot be:

- 1. There are no culture-free IQ tests. If a German is asked what is important for Eskimo children, Germans stand there dumbfounded and vice versa. American IQ tests reflect a western understanding of education, not, however, a universal understanding of intelligence or knowledge.
- 2. Higher gifting or high gifting is known to not be a guarantee for success and superiority. Most highly gifted people fail in everyday life if family or mentors are not in the background. In addition to the things an IQ test measures are various forms of intelligence that are important, for instance so-called EQ, or emotional intelligence, the ability to communicate with others, the ability to work out problems, and the ability to adapt to the environment.
- 3. Not least of all, the limitation of the investigation to 'blacks' and 'whites' is wrong, due to the fact that there are, as mentioned already, ethnicities which on average perform better on IQ tests than 'white' Americans or Europeans. This is namely the case with Jews and Japanese, whose results are 11 points higher.

Primitive Languages?

Regarding the topic of IQ, there is something to add: A portion of the IQ measurement has to do with language abilities. In earlier times it was thought in all seriousness that 'primitive' peoples had 'primitive' languages. The evolutionary theory of cultural development from a primitive people to a civilized people suggests this. We have known for a long time that this is nonsense. Primitive peoples often have highly complex and strongly differentiated languages. There is actually no such thing as a primitive language. Rather, there are at most languages which others can learn with more ease (e.g., English) or with more difficulty (e.g., Japanese).

"Modern linguistics has gone even further: every language, every dialect, has an equally complex structure. Noam Chomsky concerned himself with the ability of people to independently work through the complicated rules of their mother tongue and to build running sentences which the individual has never heard before. Present day linguists are in agreement that every small child could learn any language, independent of which language the child's parents speak. This also makes plain what linguistics can and

cannot achieve when it studies our early history. Relatedness between languages can help reconstruct migrations of people, but it can never erect a ranking between peoples." Every baby in the world is so unbelievably intelligent that it can decipher and learn every human language.

European cultural Development?

Farming was not invented in Europe, and for millennia European superiority was not expected. Even the Roman Empire, the center of which was after all in Rome, was not considered to be European. Its longest surviving piece, the Byzantine Empire, existed into the 15th century in part in Asia and even in Africa. European superiority did not develop until the 15th century and above all via the superiority in weapons technology. At around 1000 A.D. no one would have had a reason to suppose that Europeans would determine the direction of world history over a period of some 600 years. What, however, does 600 years mean in terms of genetic or biological developments? It is indeed justified to ask about the causes of the ascendancy of Europeans. Was is the good climate, the way of life and nutrition, the Christian religion, the competition that arose through the diversity of political entities, or the increased immunity against epidemics after tremendous losses due to them, which Indians in America did not experience? All theories put forward by historians were supposedly, as is so often the case, in some way or another simultaneously correct. The only thing is, they have nothing to do with the question of race or any sort of biological determination or superiority of Europeans.

5. We are all 'MixedBreeds'

'Mestizos' and 'Bastards'?

Christian Schüller and Petrus van der Let appropriately call their book *The Human Race: We're All a Mixed Breed.* The "results of genetics," according to the authors, "tell the story of people in a completely new way: It is a story of continual commingling. The more precisely we analyze a people group, the more diverse it becomes. Exceptions are the rule!"³⁹

One of the most peculiar phenomena in almost all cultures is how negatively 'racial mixing' is viewed, while year for year millions of men and women fall in love regardless of 'racial borders,' marry and have children,

and leave no one to define the borders of race. Biologically speaking there is nothing that speaks against it, and if biology is to play some sort of role, we know that an alien gene pool is always better than frequent 'inbreeding.'

'Bastard' is not only a curse word with reference to an origin that occurs out of wedlock but also has the meaning of "an animal or plant emerging by a crossing of race or species," or as a dog without a genealogy, it is up to the present, all too willingly conferred upon people. Why then do European languages only have derogatory terms and no neutral words for children born as a result of bi-national relationships?

Along with the warning about 'racial mixing' apparently comes the fact that opinions of where one's own, admissible race begins and ends varies greatly and is arbitrarily chosen. May a German marry someone who is French? It was not too long ago that such an occurrence was viewed as a racial problem. Today that is no longer the case, provided that it is a 'real' French person and not a dark-skinned immigrant . . .

Mind you, this should not be treated as if every warning about 'binational' marriages is amiss. Whoever chooses a partner with another language and from another cultural environment, just as someone who chooses a partner from another class in society, has numerous problems to overcome. Differences in language can make marital communication more difficult, and various expectations on the part of parents-in-law can make life arduous. A modern, atheistic, German woman would have a difficult time living with a prince from the royal house of Saudi Arabia. However, all of this is neither biologically nor racially based. Rather, it lies in the different language, culture, religion, education, and societal class of the people involved.

What are the actual problems that 'Mestizos' (Indians and whites), mulattos (blacks and whites), and Zambos (Indians and blacks) have in Latin America, where they often account for the majority of the population? Are they not viewed as 'mixed breeds' because we have three races in mind according to skin color, when in actual fact we are just as much 'mixed breeds'? And which German even knows whether among his ancestors there might not be Africans and Asians – this is something that genetic research suggests as a conclusion to each one of us!

Looked at mathematically, every German at Luther's time 20 generations ago had 1 million ancestors, which is to say theoretically more people than lived in Germany at that time. Since nephews and cousins married and through other kinships of our ancestors, the number is naturally reduced. But who is to say where all these ancestors came from? With 30 genera-

tions we are already at 1 billion ancestors, and with 40 generations back – for instance in the year 1000 A.D. – at theoretically 1 trillion ancestors, that is to say, a multiple of the number of all people who have ever lived. The idea that the majority of our ancestors come from a small region and not from all parts of the world is in the best case wishful thinking. Who wants to guarantee the there are no Mongoloids among his ancestors from the time when 'streams of Huns' made it all the way to France around 450 A.D.?

Out of the more than 35 million Hispanics who were counted in the 2000 census in the USA, 42.2% described themselves as belonging to 'another race,' 47.9% classified themselves as white Hispanics. 6.3% of Hispanics classified themselves as stemming from other races. In actuality there is naturally no race of Hispanics in the USA – they are a motley group from all parts of the world, who not only have English but a variation of Spanish as a mother tongue. Classifying people this way is something that arises in the heads of individuals.

The total percentage of those designated 'Pardos,' a mixed population in Brazil, amounts to 38%, and Mulattos and Caboclos (Indian and European mixed breeds) belong to this group, as do other mixed breeds. In Brazil there was a broad political stream of *branqueamento*. The intention was to

improve the 'Brazilian race' and via an admixture of 'white blooded' European immigrants cause the 'black element' in the Brazilian population to disappear. This measure was often taken by dark-skinned Brazilians who themselves tried to shake off the alleged disgrace for their offspring.

Commingling of People throughout History

The myth of 'pure blood' not mixed with foreign races over the millennia, cannot be supported by the evidence. Nevertheless, the idea simply does not die. The right wing extremist party NPD (National Democratic Party of Germany), for example, defines race as follows: 'A race is a society of people who through separation from other people over a long enough period of time have developed differently than the other people of the species and who have achieved genetic homogeneity and approximate genetic consistency."⁴⁰

Making such a statement with respect to people refutes the term race. Where has there ever been such a separation? Humanity has a history of migrations, war campaigns, trade relationships that span the globe, and even in the case of small people groups which actually have been separated for a long period of time, Bushmen or Australian Aborigines, for example, no one knows how their early history looked. Furthermore, genetics has taught us that in the past these people also migrated over great distances. In the NDP (National Democratic Party of Germany) Publishing House, Johannes P. Ney is trying to lay out a new doctrine of race, but he himself writes that there are not 'pure' human races. He also doubts that isolated Polynesians possess 'pure blood,' since as maritime masters they surely traveled extensively in the South Seas and liberally mixed with other peoples of the South Seas.⁴¹

Undiluted Germanic People or Turks?

The smaller ethnic groups are in comparison to alleged 'major races,' the more senseless it is to assume there are racial differences that were kept free of all types of 'intermixture.'

For instance, most Turks believe in a 'Turkish race.' Actually, however, as a point of intersection between Europe and Asia in the multiethnic state of the Byzantine Empire, as well as in the multiethnic state of the Ottoman Empire in what is now the soil of present day Turkey, countless people and groups have mixed with each other for thousands of years. That the father

of modern Turkey and of Turkish nationalism, Mustafa Kemal Atatürk, was himself of Albanian ancestry illustrates this fact well.

It has been attempted for a long time to view Germans and French as racially different and, for instance, to go back to Germanic people and Celts in conducting this exercise. Charles the Great is held to be the progenitor of the French king as well as the progenitor of the German emperor, and at Charles' time Franks and Germans were even able to communicate with each other by language. The first known dual language document is the agreement to split the empire among Charles' sons. Germany and France continually moved their borders back and forth, the French king had feudal possession in Germany and at times also wanted to be German emperor. For hundreds of years French was the language of education in Germany. In Switzerland and in the Alsace including Strasbourg, the two cultural groups became blurred. In spite of this, there are individual Germans who still imagine that there is genetically something such as a German and a Frenchman, and that the differences between both countries are racially based and not a question of their different languages, culture, history, world view, form of government, and legal system.

My ancestors are, for example, probably Reformed Huguenots who, after having been driven out of France, lived temporarily as 'Salzburg Protestants' in Austria. Thereafter, they migrated on to Gdansk and there reclaimed land in parts of Prussia. Who knows who would show up if I looked back twenty generations into my ancestry? Am I a German or a Frenchman?

If anyone in Central Europe wants to speak of some sort of race that is in any way stable after all the 'racial mixing' that took place in the Roman Empire, subsequent migrations, campaigns of conquest from every direction, the invasion of Asian troops on horseback, and immigration from all over the world, then the only explanation is that the wish is father to the thought and the modern nation state would like to have a biological, religious, or other type of fixed anchoring for its citizens. Studies of Y-chromosomes suggest that the people of Europe have no identifiable origin but that they all go back to repeatedly new waves of immigration from all different directions.

I wrote my first dissertation on Theodor Christlieb, who was by birth a Württembergian and primarily active in Bonn as a theologian in the 19th century. He has the following circumstances to thank for his name, namely that his grandfather was a Turkish foundling baptized "Christlieb" by Württembergian foster parents. He held himself for a stalwart German.

Kaiser Wilhelm II did as well, for he called him to be court chaplain. Christlieb was albeit unable to take on the post due to his death.

Again it is genetic research, with it very latest results, that comes to our aid: "Only a few Germans are truly Germanic: Only about six percent of all Germans have Germanic origin on their father's side. This is what is maintained by a study from a genetics laboratory. According to the study, 30% stem from Eastern Europe. And there was some additional information that came out as a result of this: German women are more German than men. Every one out of ten Germans has, according to a Swiss study, Jewish ancestors . . . Researchers additionally [found] out . . . that only six percent of all Germans had Germanic origins from the father's side. According to the study, 30% stem from Eastern Europe. For the study, which has been unpublished up to now, 19,457 genetic analyses were compared. Moreover, in the course of their investigations of maternal lines, the genetic researchers came to the conclusion that German women are more often of Germanic ancestry than German men, namely 50% of them. Researchers explain this difference as due to the shorter lifetimes of masculine forefathers. Modern genetics show the senselessness of racism, says Imm Pazos, who is one of the scientists associated with the study. All genetic analyses demonstrated that every person has countless roots and in every person there is a 'mishmash.'"42

I make no pretence of the fact that I am admittedly a non-scientist who is somewhat concerned about whether science, in the case of genetic research, has bitten off more than it can chew. It could be that much of what is maintained today will be adjusted by the next generation of genetic researchers. However, even if that were to be the case, none of it would presumably provide a meaningful basis for a return to racist thinking.

Excursus: Was the Old Testament Prohibition against Marriage to Non-Jews racist?

The Old Testament often reports on divorce from unbelieving, pagan women (e.g., Ezra 9:1-10, 44, in particular Ezra 9:1 and Ezra 10:3; Nehemiah 9:2; 10:29; 13:3; Malachi 2:10-16). The prohibition against marrying non-Jewish partners was, however, not a racial but rather a religious prohibition. What was prohibited was "marrying the daughter of a foreign god" (Malachi 2:11b), that is to say, a woman who believes in another god. If a heathen, either male or female, converted to the God of Israel, they were

indeed able to be married, just as vice versa one was not allowed to marry a Jewish male or female who served foreign gods. In Jesus' genealogy (Matthew 1:1-17) Matthew four times mentions women, and indeed each time it has to do with a heathen woman: Tamar, Bathsheba, Rahab, and Ruth. Ruth was by nature a Moabite (Ruth 1:4) and that, although the Moabites were specifically excluded from God's people (Deuteronomy 23:4). However, because she swore to her mother-in-law: "Your people will be my people and your God my God" and with that converted to the Jewish faith, she was able to be taken as a wife by Boaz and become the most well known matriarch of David and Jesus.

II. On the History of Racism and its Justification

1. The History of Racist Theories

Antiquity

It is a matter of dispute whether there was racism in antiquity or not. Some argue that there was neither anything corresponding to the term 'race' nor was there anything that was likened to the later contempt for 'blacks.' Antiquity was enormously multicultural, and the idea of "one people, one nation, one state," that is to say, the nation state, was completely unknown in antiquity. Even slavery followed ethnicity less than being proof of the fact that class differences were an understood part of all societies of antiquity.

As a start there was, however, racism in other regions of the world. The Chinese disdained all people who did not belong to the 'middle.' Also, the Indian caste system can be categorized as racism, as I will expound further below.

The Middle Ages and the Enlightenment tied in with the Greek philosopher Aristotle, who taught that 'barbarians' were by nature inferior and for that reason born for slavery. One had to deal with them as with animals. Even if what Aristotle meant by 'nature' (*physis*) was raison d'être and not biology as was later the case, what is found here is the connection between a biological-bodily group membership with features of incapacity for civilization and a resemblance to animals that justified, yes, even obliged them to, enslavement.

The Emergence of European Racism in the 15th Century

With the Christian doctrine of universal human dignity, "a new concept that had been foreign from antiquity up to that time" ⁴³ appeared in world history. In the narrower sense, the actual history of European racism only began in the 15th century, after almost a millennium of Christian history.

It could actually be said that prior to 1400 there were no ideologically defined 'races,'⁴⁴ if it is true that Arabian slave traders did not develop their view of the inferiority of black slaves at an earlier time. In any event, beginning in 1400 Spaniards and Portuguese, through their business rela-

tionships, not only brought the Arabian slave trade to Europe but also, with the slave trade, the idea also came that black Africans were either not human or less than human⁴⁵ and could not even be converted to Christianity. In addition there was the Islamic point of view that Noah, in Ham, had cursed the black race.⁴⁶.

At the end of the 15th century and beginning of the 16th century, as a consequence of the *Reconquista*, which was the Christian recapture of all of Spain, a new point of view established itself in Spain. To be sure most Jews and remaining Muslim Moors had been forced to be baptized from 1492 onwards, but now what had been a common religious intolerance had become a racial intolerance. On the basis of their ancestry, Jews and Moors also remained unbelievers and enemies after baptism.

Therefore, alongside the Spanish politics of 'blood purity' (*limpieza de sangre*), Anti-Semitism also took on a new form. It was the Jews who had converted to Christianity or their offspring (Marranos) who became the target, since their religious confession was mistrusted. Whoever had only one grandparent of Jewish descent was not considered 'pure blooded' and was considered dangerous.

A group with common roots is what develops out of a believing Christian community. Actually, everyone who is baptized becomes a part of it. What became of it, however, was a community of heredity, into which a person was born. It was not able to be reached from without, and that is a perversion of the New Testament message.

It is paradoxical that this racism emerged in Spain and Portugal, because simultaneously in the new colonies in Latin America and Middle America the mixing of 'races' was normal. Beginning in 1500 Spaniards wrestled with the question of their relationship to Indians in Latin America. In 1550 the Dominicans Francisco de Vitoria (1492-1549) and Bartolomé de las Casas were able to come out on top in the so-called Valladolid debate as advocates for the Indians against Juan Ginès de Sepúlveda. Indians were thus seen, according to royal and papal law, as people with rights who could convert. Las Casas wrote: "All the races of the world are men, and the definition of all men, and of each of them, is only one, and that is reason." Reality looks different. Beginning in 1510, Aristotle's idea that the

enslavement of barbarians was due to their more base human nature was increasingly transferred to 'blacks.' As long as Indians and 'Negros' were able to convert, they were protected by the Christian understanding. Therefore, what began to happen on a grand scale was to report on human sacrifice and cannibalism – and today we know that these reports were largely unjustly made – so that the oppressed people could either be portrayed as *unable to convert* and irreversibly bad or portrayed as *beastly* and inhuman.

All of this helped 'blacks' very little, because of all things Las Casas despised them deeply. Provided that the corresponding passages truly came from him, they gave birth to the idea that in order to protect the Indians, black Africans were to be sent as slave substitutes to the colonies.

The Word 'Race'

The word 'race' reflects the development towards racism from the 14th to the 19th century. The German word 'race' comes from the Romance languages, where *raza* (Spanish), *raça* (Portuguese), *razza* (Italian) und *race* (French) have been used since the 13th century. In German *race* was used for centuries. It was not until the 19th century that the word was Germanized to *Rasse*.

The word was originally used to designate the ancestral lines of aristocrats, that is to say, people of 'noble' or 'blue blood,' in addition to bred races in horse breeding.

Regarding the 'noble blood' of aristocrats, the following can be said in passing: I hold the idea of biological races of humans to be a myth, just as it was in the case of 'nobility.' Even if millions allow themselves to be ruled, because they view aristocrats as hereditarily conditioned for something better, it really has to do with nothing other than a fictitious, if successful, ideology to defend a certain social order. The higher nobility is *de facto* neither automatically bestowed with intelligence nor leadership charisma, nor with health or an understanding of the principles of justice. Rather, it is only a question of one's own feeling of superiority...

Racism in the Enlightenment

"Practices of discrimination against minority groups have a long tradition. Up until within the 17th century such exclusionary actions were primarily religiously based. In the course of the 18th and 19th centuries, theo-

ries and ideologies came along that people used to classify and hierarchically organize people into biological groups ('races') on the basis of physical, ethnic or cultural features with genetically inheritable characteristics. These ideas served as a basis for justifying colonialism and imperialism as well as domestic actions and discrimination designed to promote the preservation of social and economic privileges." ⁴⁹

It was 200 years later, precisely at the time of the explosion of knowledge and of the 'Enlightenment,' that racism was brought into a new phase. "The scientific thought of the Enlightenment was a precondition for the growth of a modern racism based on physical typology." It was this that allowed the Christian 'brake,' that all people are in equal measure the posterity of Adam and images of God, to finally be dissolved. "What made the concept of race so fascinating for philosophers such as Voltaire or Kant, as well as for those who were interested in natural history in the narrower sense, . . . was the promise of a natural order, which meant above all describing and organizing the world in a manner that was independent of the teachings of the church and of the people of the church." ⁵¹

According to George M. Fredrickson, "one can easily portray Voltaire as the first thoroughgoing modern racist." The French philosopher actually wanted to criticize Christianity when he questioned the common origin of all human races, but his derogatory statement about black Africans or Jews, for instance, went in a completely different direction, and that, although Voltaire rejected slavery. Even as the Enlightenment fought against slavery and set Jewish emancipation in gear, it continued to expand racial thought and with it justified the most wicked form of contempt for 'Negroes,' comparing them with apes.

The Enlightenment developed the model of historical progress from the nomadic life as hunter-gatherers via the stage as herdsmen and farmers all the way up to civil society, which provided the precondition for social Darwinism. In this way the 'gypsies' *per se* were primitive, because they had been vagrant people traveling around in covered wagons for centuries.

The first person who attempted to make a scientific classification of the human race in modern times was Carl von Linné (1707-1778). He was the founder of modern biological taxonomy and had been strongly influenced by Aristotle. In 1766, within the framework of his groundbreaking subdivision of the entire plant and animal world, he placed humans ('Tagmenschen') within four species, named according to four ostensible colors of their skin (Americanus rufus = red American, Europaeus albus = white European, Asiaticus luridus = pale yellow Asian, Africanus niger = black African) and their alleged temperaments going back to Greek antiquity.

"Whatever it was that Linné, Blumenbach and other ethnologists had in mind, they were in any case the pioneers of a secular or 'scientific' racism."⁵³ "Through the evaluation of phenotypic characteristics on the basis of aesthetic criteria, as well as through the combination with intellectual, temperamental and cultural abilities, the race typology that had been worked out in the 18th century prepared the soil for the completely unfurled biological racism of the 19th and 20th centuries."⁵⁴

Joseph Arthur Comte de Gobineau (1816-1882) is considered the inventor of the idea of the Aryan master race and founder of modern 'racial doctrine,' which prepared the way for the worst racism in history. It is interesting that one of the earliest uses of the term race came in the 15th century with reference to nobility, since Gobineau explained the demise of his status of nobility with reference to racist degeneration that came about by racial mixing. He prophesied that mixing blood from different races would lead to the extinction of humanity and, thereby, influenced the oft unexpressed negative feelings associated with 'racial mixing.'

Evolutionary Theory and Social Darwinism

What is meant by social Darwinism is the use of evolutionary theory to understand human society and its development as a result of the 'fight for survival.' Franz Stuhlhofer has shown that the use of evolutionary principles such as the fight for survival and the survival of the fittest has been appallingly taken by Charles Darwin himself and applied to humans and peoples. 55 The classic representatives of evolution, such as Herbert Spencer, Edward Tylor, and Lewis Henry Morgan, assumed that human societies, just as biological species, are subject to development processes,

in which success and survival of those best suited lead to permanent improvement in the group.

"If it were amiss to say that there is a direct path from social Darwinism to the Third Reich and its practices based on heredity and race, then it is still the case that the 'direction and ideation' that took on a specifically channeled life form in the National Socialistic state was inspired by social Darwinism. When Hitler proclaimed in *Mein Kampf* that there is no special status assigned to humanity, one has to 'understand and grasp the fundamental imperative of the workings of nature' to which humanity is also subject, he drew on the biological-monistic worldview that had long before him become the credo of social Darwinists." ⁵⁶

It actually appeared to be the case that evolutionary theory, which did away with mankind's special position in the natural world, provided a good explanation for the development of cultures and the differences one finds between people groups. And it all appeared to be scientifically based. It appears, too, that it is always good if science receives an ethical requirement and is testable and able to be critically analyzed outside of science. "Scientific racism of the explicitly or implicitly polygenetic kind did not take hold in England until after the mid-nineteenth century, mainly because of the strength of evangelical Christianity and its commitment to the belief that all human beings descended from Adam. . . . In France ethnological discussion was uninhibited by Protestant Evangelicalism and could take a more radical turn than in Britain or even the United States." 57

In the meantime evolutionary researchers have themselves corrected many of the errors that led them straight into racism, and in so doing have returned to some once derided points of view, such as, for instance, that all people have a common ancestry. But over against all appeals to modern scientific research results, we should retain a certain healthy skepticism regarding scientific results that are presented as if they were absolute final conclusions.

Colonialism

Any book about racism should actually include a history of colonialism, which, however, is not possible to present in a short and compact manner. Racism, according to many historians,⁵⁸ was admittedly not the decisive

ideology found everywhere among all colonial rulers. Often it only provided a retroactive justification, for instance to the homeland's inhabitants. Additionally, colonialism was also strongly influenced by competition and war that existed between Europeans. In this connection one thinks of the Boers and British in South Africa, who did not balk at exploiting 'whites.'

'Colonial Times' are designated as a modern epoch, based on the colonialism emanating from European powers, and that commenced at the beginning of the 15th century. It's petering out was touched off by the end of World War II, such that from 1946 to 1965 almost all earlier colonies became independent. Next to this there were, naturally, colonial times and colonial powers, such as the Roman, the Ottoman, the Chinese, or the Soviet empire, that throughout all times and on all continents were connected with the subjugation of many people.

Furthermore, with the term 'imperialism' one designates, if you will, the collecting of colonies, i.e., an orientation in national politics that seeks the domination of as many regions and peoples as possible within the framework of a global struggle for power. With this, then, comes a global and political influence that extends well beyond one's original dominion.

Slavery

While African peoples had enslaved each other for a long time, and while Arab princes finally became the lords of the African slave trade, the European entanglement began in 1444 when a Portuguese expedition in Lagos unloaded 235 slaves from Mauritania. In 1510, the first 50 black Africans were brought from Spain to Haiti to work in the silver mines, and in 1619 the first slaves arrived on the soil of what is today the United States of America.

The transatlantic slave trade was born, ⁵⁹ which was a business triangle in which cheap goods, hard liquor, and weapons from Europe, through the inclusion of Arab slave traders, were often exchanged for slaves, and these slaves were then exchanged for American colonial goods. With this it was taken for granted that there would be a social and physical death of a portion of the slaves, since slaves were valued and treated as goods. Between 1450 and 1900 it is estimated that 11.7 million slaves from Africa were carried off to America. Of this total, 9.8 million actually found America to be their country of destination. Between 1 and 2 million slaves died during approximately 50,000 passages.

Excursus: Evangelicals and Slavery

In addition to other economic and social factors, Evangelical revivalism was significantly involved in bringing an end to slavery. It is at this point that the designation *Evangelicals* came about in the first place. This applies to the legal abolishment of slavery in Great Britain as well as to the anti-slavery movement in the USA.⁶⁰

It was in 1688 that Quakers in England and the USA first demanded that all slaves be released. By 1780 all Quakers had released their slaves. George Whitefield und John Wesley, who set 'Methodist' revivalism in motion in England and the USA, fought vehemently against the 'sin' of slavery. Wesley published his book *Thoughts upon Slavery* in 1774. Beginning in 1784, slave owners were excommunicated by Methodists. In England many friends of Wesley who were involved in politics became active against slavery. The most famous of these is William Wilberforce (1759-1833).

William Wilberforce had been a representative in the British House of Commons since 1780. He converted to Evangelical Protestantism in 1784 on a trip through continental Europe and founded the *Abolition Society* in order to elevate morals and especially abolish the slave trade. In a Parliamentary meeting in 1789, Wilberforce, along with William Pitt, for the first time petitioned in the House of Commons to abolish the slave trade. Again in 1792 a petition was filed, this time successfully. Yet implementation was prevented due to war and the situation in the colonies. It was not until 1807 that an act of Parliament ended the British slave trade. Slave traders within the British sphere of control were viewed as pirates and punished. The United States of America followed, whereby beginning in 1808 the slave trade was forbidden.

At that point Wilberforce set his sights on implementing this prohibition in the rest of the civilized world. Upon his urging, Lord Castlereagh successfully raised this as an issue at the Congress of Vienna. Finally, there were agreements in which France, Spain, and Portugal obligated themselves to forbid the slave trade

After the slave trade was abolished, Wilberforce finally became active in ostracizing and eliminating slavery itself. In 1816 he presented a motion in Parliament to reduce the number of slaves in the British West Indies. The government began preparing the emancipation of all slaves in 1823, and Wilberforce held impassioned speeches throughout the fierce debate until in 1825, due to health reasons, he had to retire. He died in 1833 and was buried in the church of the British crown, Westminster Abbey.

Slavery Today

Unfortunately, slavery still exists, even if in the meantime it is prohibited almost everywhere, lastly in Saudi Arabia in 1962 and in Oman in 1970. Slavery in Africa is flourishing around the Sahara, namely in Mauritania, Mali, Nigeria, Sudan, and Chad as it has in the past, whereby the owners are mostly Muslim Arabs and the slaves mostly 'blacks.' The number of slaves in Mauritania is estimated to be 100,000.

The oldest human rights organization in the world, the British organization *Anti-Slavery International*, reckons that there are 100 million slaves worldwide. In India and Pakistan, slaves primarily work in stone quarries, and in Pakistan alone the number of slaves is estimated at 20 million. In Thailand, Brazil, and India it is children who are above all enslaved, many of them in the prostitution industry. The most widely spread form of slavery today is a brutal form of debt servitude, by which families incur higher debts for their work implements than they receive in wages. Among the

worst slavery is ironically found in the Dominican Republic amidst Haitians, although this is the only country in which African slaves were successful in acquiring control of the government. About one million slaves still work there on sugar plantations.

Excursus: The Death Penalty for Slave Traders in the Old Testament

The term translated 'slave' in the Old Testament is ambiguous, because it is all too easy to read into the Old Testament the cruel slavery conducted by the Greeks, Romans, Muslims, Europeans, and Americans. For this reason it is better to speak of 'debt servitude' or 'service,' and often of 'workers' instead of 'slave,' 'servant,' or 'footman.' The legal status of slaves/servants in Israel over against other peoples was remarkably good. They could ask for damages in the case of bodily harm, go to court, buy their freedom, etc. ⁶²

How did someone (lawfully) become a slave or servant in the Old Testament? It was in any event never lawful to become a slave through kidnapping or the sale of people, because the death penalty was required for such action: "Anyone who kidnaps another and either sells him or still has him when he is caught must be put to death" (Exodus 21:16). It should be emphasized that the New Testament writers did not overlook the mistakes of slavery. The Pauline list of law breakers includes slave traders (I Timothy 1:9-10, literally: 'people traders'). "John incorporates slavery into his analysis of wrongs which pervade Babylon: wrongs for which the city is judged (Rev 18:13)." The same Paul who encouraged slaves to work hard and to maintain their Christian life could also write: ". . . although if you can gain your freedom, do so" (I Corinthians 7:21b). In Philemon Paul pleads for the release of a slave.

2. Genocide

Genocide under international Criminal Law

Genocide, first included within international criminal law, was increasingly made a punishable offense in many national legal systems. In 1948 the General Assembly of the United Nations produced a resolution in the

"Convention on the Prevention and Punishment of the Crime of Genocide," which went into effect in 1951 and which was ratified by Germany in 1951, by Austria in 1955, and by Switzerland in 2000. The Convention defines genocide as "any of the following acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group, as such: (a) Killing members of the group; (b) Causing serious bodily or mental harm to members of the group; (c) Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; (d) Imposing measures intended to prevent births within the group; (e) Forcibly transferring children of the group to another group.

Within the framework of the United Nations and international law, genocide is the gravest offense. Moreover, and unlike a war of aggression, it is clearly defined and something for which international criminal courts and tribunals are used. It can also be prosecuted by countries other than those subject to it. Since the cases of genocide in Yugoslavia and Rwanda, for which international tribunals have been utilized, and since the formation of the International Court of Justice in Den Haag in 2003, the condemnation of genocide has increasingly taken on practical importance.

With this it is to be noted that it was not just the carrying out of genocide, but rather the intention to commit genocide which is sufficient for a charge. On the other hand, the sheer killing of many people belonging to a group, which is not done in a genocidal sense, is not yet considered to come under criminal law.

The Steps to Genocide

- 1. Classification a particular group is distinguished from 'us.'
- 2. Symbolization Hate symbols and terms of hatred stigmatize the group.
- 3. *Dehumanization* A group is compared with sub-humans, apes, animals, viruses, etc.
- 4. *Polarizing Propaganda* Propaganda provides the condition whereby genocide is seen as normal or unavoidable and can be supported.
- 5. *Organization* The preconditions for genocide are created, e.g., via arming, the construction of camps, but also bureaucratically by compiling or registering the group.
- 6. *Extermination* The actual murder occurs via mass killings or by depriving people of their basis for survival.
- 7. *Denial* During and above all after extermination genocide is denied, ascribed to completely different perpetrators, or traced back to non-racist, alleged factors that can be otherwise explained

Examples of Genocide

Aborigines in Australia: The British settlement that began in 1788 led within 120 years to the almost complete extinction of the original inhabitants of Australia and neighboring islands. Although no official numbers are available, the estimates range from 250,000 to 750,000 Aborigines in 1788, which by 1911 had shrunk to 31,000. Genocide committed against Aborigines and their oppression ran through three phases. Up until about 1900 Aborigines were practically unprotected game and were driven off by the scores and hunted and killed as game. They were not considered people, but rather dangerous animals. As a result of massacres, the British government enacted a law in 1897 called the Aborigines Act, a law protecting the original inhabitants that had as a result geographical racial separation. Aborigines then began to live in enclosed remote woodlands and island areas, which they were not allowed to leave and into which no settlers could go. Beginning in the 1920s, an assimilation policy was also instated. The children of original inhabitants were taken from their parents (estimates for 1910-1970 range from 10% -30% of all children) and put in homes or with 'white' families, and later married to 'whites.' Whoever could demonstrate how 'white' he or she had become (via marriage or lifestyle) could apply for citizenship and the right to vote. It was not until 1996 that Aborigines received the right to vote, and it was not until the 1980s that racial segregation in the schools was repealed.

Genocide of Armenians in Turkey: "Prior to World War I, the largest indigenous⁶⁴ ethno-religious minorities were Armenians and Greeks, who accounted for 2.5 million and between 2.7 and 3 million people, respectively, in the Ottoman Empire. In the last decades of Ottoman-Turkish rule they, along with Aramaic speaking Christians (self designated: Syrio-Arameans, Assyrians, Chaldeans), became the sacrifices of state planned and directed massacres as well as deportations, which genocide research assesses as genocide according to the criteria of the UN Genocide Convention (1948). It was namely the genocide of 1.5 million Armenians of Ottoman citizenship, together with the massacre of Assyrians in Iraq in 1933, a prototypical genocide, which prompted the author of the UN Genocide Convention, Raphael Lemkin, as the legal adviser of the League of Nations, to introduce the draft of a corresponding international contractual framework into the League of Nations. He failed, however, due to the resistance of the delegation from Nazi Germany. While the Armenian population of the Ottoman Empire shrunk by three-fifths within two years (spring 1915 to February 1917), the extermination of the Greek Orthodox

population lasted a decade and was executed at varying locations. It is for that reason called a cumulative genocide."⁶⁵

National Socialism 1933-1945: The "Holocaust" (from the Greek term for 'completely incinerated,' i.e., 'burnt offering') or shoah (Hebrew for 'disaster,' 'great catastrophe') is what one calls the genocide of at least 5.6 million to 6.3 million Jews during the time of National Socialism. World War II cost the lives of 15.8 million non-Germans and 4.2 million German soldiers and members of paramilitary units, as well as 15.8 million non-German civilian victims and 500,000 German civilian victims of aerial warfare. 2.27 million members of the German civil population died as they were forcibly displaced from the East. And all of these are rather low estimates. Especially alarming is that out of this total the direct number of National Socialistic crimes not included as actions of war according to the current state of research is 13 million people, among them 6 million Jews, 3.3 million Soviet prisoners of war, 2.5 Christian Poles, a further 784,000 non-German victims from all over Europe in concentration camps and work camps, 296,000 Sinti und Roma (gypsies), 100,000 mentally ill and handicapped as victims of euthanasia and 130,000 non-Jewish Germans involved in political or religious resistance. I have listed all of these numbers, because it is also meant to remove any basis sought for the so-called 'Auschwitz lie.' The 'Auschwitz lie' is a contentious term by which those who deny the reality of the Holocaust maintain that it is impossible to think that around 6 million Jews were killed.

Mass Extermination by the Khmer Rouge: During the reign of terror of the Khmer Rouge in Cambodia from 1975-1979, it is estimated that out of a total population of 7 million, 1.4 million to 2.2 million inhabitants were killed. One-half were killed in death camps and the other half through forced labor in the rice fields or through starvation. The mass killings are termed 'auto-genocide' by experts, since the Cambodian people almost killed themselves off. Many researchers view the mass murders of the Khmer Rouge not as genocide but as something purely politically motivated. Indeed, in such case there was still among the mass murders genocide with respect to a portion of the killings, so it can be said that almost all Vietnamese in the country were killed out of a racist motivation.

Genocide in Rwanda: Between April and July 1994 the army, police, and civilian population of the Hutu majority killed approximately 800,000 to 1 million people. In so doing, they killed 75% of the Tutsi minority living in Rwanda as well as moderate Hutus, who did not participate in the

genocide. Neighbors killed their neighbors with machetes, and the remaining Tutsis fled to the Congo, Burundi, and Uganda. The UN's own criminal court has met since 1996, and hundreds of thousands of victims have been dug up and buried. Typical for the senselessness of racism is the fact that the Hutu and Tutsi are not really different people groups. Rather, they are social stratifications. At least it can be said that no difference at all was made between Hutu and Tutsi prior to 1916. Germans and then the Belgian colonial masters relied on the richer Tutsis in order to control the country, and they additionally considered them to be Aryan. When independence was granted in 1962, the Belgians saw to it that the Hutu, who represented the majority of the population, received power. In 1994 the accidental death of the Hutu president provided extremists the pretense for seizing power and conducting genocide. The international community looked on silently for three months, until the military arm of the Tutsi resistance conquered the capital of Kigali with the support of neighboring countries. 66

Srebrenica Massacre: In July 1995 up to 8,000 Bosnians, primarily men and boys between the ages of 12 and 77, were killed in the area of Srebrenica by members of the Serbian army, police, and paramilitary. In 2007 these actions were determined by the International Court of Justice to be genocide.

Genocide in Darfur: Since 2003 there have been armed conflicts between black African tribes in Darfur in the Sudan and the Arab-Muslim central regime in Khartoum. The rebel movement calls for codetermination and the development of their region. Against this movement the central government has taken steps with, above all, the local militia consisting of mounted Arab Nomads (Janjaweed). Up to the present 400,000 people have died and 2.5 million have fled within Sudan or into neighboring countries. The destruction of villages, massacres, and rape are the order of the day. 'Black African' and 'Arab' are actually senseless categories, since only 2% of all inhabitants of the Sudan are of Arab descent. The conflict goes back to earlier rivalries in the slave trade and to economic contrasts, whereby the Fur and Masalite were settled farmers and the 'Arab' Baggara and Zaghawa were nomadic stockbreeders.

Unwanted Genocide due to Racism

Not every actual case of genocide is desired, at least not when looking at history. Often what was sought was only the dependence or compliance of an ethnic group, and yet people died due to poor living conditions or unforeseen factors.

An example is the widespread death that occurred among Indians in Middle and South America and in North America at the beginning of the European discovery and conquest of America. Even if there are several examples of the slaughter of small groups of Indians, the shrinking of the Indian population by 90% is not something that can be traced back to specific murders or cases of being killed off. Rather, it above all, has to do with epidemics that were brought in and against which the Indians were not immune, the danger and spreading of which was not known until centuries later. In addition to this, the Indian physical constitution was such that the slave work in the fields or in mines, which the Europeans and the Africans survived, was not something with which the Indians were able to cope.⁶⁷

In any event, the number of Europeans in Middle and South America was too small for there to be genocide. Additionally, the Europeans' goal was to rule over people and become rich, not to eradicate people – all without wishing to sugarcoat their racism.

In North America it was not until much later, after the number of Indians had been decimated and 'black' slaves had been seen to be much more able to survive and more easy to exploit, that the Indians were 'in the way' of the European settlers. The attempts at a solution were no longer through genocide but rather through forced displacement to reservations. However, that was able to again lead to race based murders in cases where those who would not acquiesce were submitted to bad living conditions or were warred against.

Threatened Peoples

"The number of peoples or ethnicities cannot even be approximated. The same thing applies here that applies to the number of languages. It is a question of definition, whether one, for example, counts Arabs as a people or does so with each Arabic tribe or each Arabic nation (Syrians, Lebanese, Jordanians, etc.). The number of ethnicities is greatest in Asia and Africa (in each from 1,800 to 2,000 in number). In Europe, according to the way the counting is conducted, one arrives at a number of 120 to 150 (without immigrants)." In light of the approximate 200 nations worldwide it is clear that most of the ethnicities of this world do not have their own country. Many peoples live in peace with others in multiethnic states, but a large number live as threatened ethnic minorities ruled by majority peo-

ples, experiencing everything from light discrimination all the way up to attempts to assimilate them completely or to force their displacement or extermination.

I regret it deeply that due to the limited scope of this book, no picture can be given of some of these threatened peoples beyond examples provided at other junctures, and not in the form found in the encyclopedias mentioned in the bibliography.

Excursus: Diversity of Cultures in the Bible

God is the creator of all people, because "from one man he made every nation of men, that they should inhabit the whole earth . . . (Acts 17:26a; comp. Deuteronomy 32:7-9; Psalm 74:17; 86:9). For that reason a Christian loves people of all cultures and respects the differentness of other cultures (Revelation 1:6-8; Psalm 66:8).

Many Christians see the differences between cultures in a negative light and understand them as a result of sin. For them it is a consequence of the judgment of God due to the confusion of languages at the building of the Tower of Babel (Genesis 11:1-9). With the confusion of languages God wanted to achieve that which he had before given to mankind as a command, namely the proliferation of mankind over the whole earth ("fill the earth," Genesis 1:28; 9:1) and with it the splitting of humanity not only into a diversity of families and peoples but also into vocations, abilities, and cultures. With the construction of the Tower of Babel a unified world culture was to have been created. This has always been the goal of Satan, as is shown in the book of Revelation and in the person of the Antichrist in the Old and New Testaments. And this is what is said of the 'beast,' which has his power from the 'dragon' (Revelation 13:1-10): "He was given power to make war . . . And he was given authority over every tribe, people . . ."

God and his word guarantee the unity of the world but not, however, a visible structure on earth. God 'scattered' people "over the face of the whole earth" (Genesis 11:9b). Extending from the Sons of Noah, "came the people who were scattered over the earth" (Genesis 9:19) and so the "nations" were "spread out" (Genesis 10:5). In this way the individual peoples can be explained through lines of descent (Genesis 10: 1-32), at the end of which it can be said: "From these the nations spread out over the earth after the flood (Genesis 10:32b).

It is no accident that the drifting apart of cultures begins when families drift apart. Every family has its own culture, and God has so created man that without exception one's own children even create their own little cul-

ture, which always differs at least some from that of the parents. It is a process that over generations has far-reaching consequences. These different cultures that children have are enhanced when children marry children from other families and, with them, marry into different cultures. God consciously mixes different cultures and influences in marriage. Social and cultural conflicts are not automatically an expression of moral failures. Rather, they are normal and are a consequence of a diversity desired by God.

Already in the Old Testament, God made it repeatedly known that he was thinking about the salvation of all peoples (Genesis 12:3; Isaiah 49:6, etc.). Jonah's mission exemplifies the universal nature of divine salvation as early as Old Testament times. Pentecost makes it clear that the church of Jesus extends beyond all cultural and language barriers. For this reason the church was laid out multi-culturally (Revelation 5:9-10; 7:9; 10:11; 11:9; 13:7; 14:6; 17:15; Daniel 7:13-14; Ephesians 2:11-19).

3. Racial Segregation

Racial segregation means the forced and firmly set separation of people groups defined as 'races' in all areas of life. Typical segregation would include prohibition on marriages between members of different 'races,' physically separate residential areas as well as separate public facilities such as schools, universities, public transportation, restaurants, beaches, and toilets, whereby the facilities for the leading group are as a rule better equipped.

The most prominent examples are Germany's Third Reich from 1933 to 1945, the USA from 1890 until the middle of the 1960s, and South Africa beginning in 1900 and above all from 1948 until 1990. In the USA one speaks about racial segregation as the time beginning after the end of slavery. Rhodesia (at first 'white' against 'black,' and now 'black' against 'white') and Australia (against the Aborigines until 1966) are additional examples. In a certain sense Northern Ireland also belonged within this group up until a short time ago.

USA

The history of America has three central racist themes. These are the expulsion of the Indians, the deportation of African slaves, and as a counterpart thereto, the establishment of the dominance of 'whites.' In addition to this are further areas of racism that can be named but never took on the same proportions, for instance, the prohibition against the immigration of gypsies, suspicion towards Irish Catholics and later towards Spanish-speaking immigrants, restricting immigration from Southeastern Europe, and widespread anti-Semitism until the middle of the 20th century. It is naturally impossible to present a history of the USA at this point.

In the South of the USA an officially racist justification for slavery first developed in the 1830s, when the anti-slavery movement began in the northern section of the USA. With the victory of the northern states in the American Civil War, and along with it the end of slavery in the southern states, traditional racial segregation, above all in the southern states, was placed into question. Subsequently, a number of southern states, as well as states bordering them, passed laws that legally anchored racial segregation.

The Supreme Court in the USA *de facto* confirmed the laws in 1896, in that it held racial segregation as permissible, insofar as the facilities and services that were made available were equivalent (*separate but equal*).

In 1948, shortly after World War II, the abolishment of racial discrimination began in the US Army and in federal service, and additional legal improvement followed. In 1954 there was a Supreme Court decision against racial segregation in education. But it was in the wake of the American Civil Rights Movement in the 1960s, representatively connected with the name of the Baptist Pastor Martin Luther King, that racial segregation laws were abolished little by little. In 1964 the Civil Rights Act of that same year rescinded all remaining laws against 'blacks.' It was not until 1967 that the Supreme Court lifted the prohibition on marriages between blacks and whites. The legal equality of the 11% of the population of the USA that is 'black' was complete, but the consequences of earlier racism have by no means been removed.

At this point it should be noted that Europeans often display an almost racist view of the USA, as if they themselves are free from racism and the USA is incurably racist. Richard Heringer writes in this connection: "That Barack Obama, as a black American, for the first time has a realistic chance to become President of the United States of America is in fact a great incision in history, and he is thus highly recognized. In our reporting, however, almost all attention is given to the question of the degree to which Obama's being black is in the final analysis an insurmountable handicap for American voters. Strangely enough that appears to be ambiguous... In order to measure what has been achieved in the United States in the past three or four decades in this respect . . . counter questions suffice: Could you imagine that in the 2009 Bundestag elections a German of Turkish ancestry could be nominated as the leading candidate of one of the largest political parties? That a politician with a Moroccan father and an Arab name could challenge Nicolas Sarkozy for the office of President of France? Or that a politician of African ancestry would be considered for the post of the President of the European Commission? . . . With respect to diversity as well as to immense efforts to overcome racism in the public sphere or at least to socially discourage it, the USA is far beyond Europeans – not to speak of other parts of the world."⁷⁰

South Africa

"The one racist regime that survived the Second World War and the Cold War was the South African, which did not in fact come to fruition until the advent of apartheid in 1948," even if apartheid had a political history in the special segregation of 'blacks' into so-called 'homelands.' If in 1948 the descendants of the British had the say in South Africa, in 1948 it was the racist Boors of Dutch descent who won the elections and introduced strict racial segregation. It in turn was divided into two types of segregation, Petty Apartheid and Grand Apartheid.

Petty Apartheid meant racial segregation in the public service area, such as, for instance the prohibition against blacks' entering public parks, separate compartments in public transportation or separate schools. City halls, hospitals, postal buildings, banks, and toilets mostly had two entrances, one for 'whites' and one for other 'races.' Additionally, one knew by word of mouth in which restaurants, etc. 'blacks' would not be served. Naturally, along with this came exclusive voting rights for 'whites.'

Grand apartheid meant the so-called homeland policy, which involved the settlement of most 'blacks' in alleged small states within South Africa. In addition to this, there were separate residential areas in each city and village corresponding to skin color ('white,' 'black,' 'colored/Asian').

Apartheid included a huge administrative apparatus. It is estimated that 4 million 'blacks' were arrested due to missing residence permits. Millions of people were resettled as a result of the 1952 *Native Resettlement Act*, which was a challenge administratively as well as for the police. Protests against the act necessitated mass arrests and required large prisons or camps. The destruction of large existing settlements, because they were held to be illegal or were used to make room for white neighborhoods, required an enormous infrastructure.

In my opinion, the story of apartheid in South Africa is still not over, not only because the earlier Apartheid under the 'whites' still continues to have effects and decades of neglect of large parts of the population are not quickly made up for. Rather, many 'colored' and people of Indian descent continue to be discriminated against and a severe 'black' racism not only against 'whites' but against alleged immigrants from other African countries has spread. Old antagonism between Xhosa and Zulu, etc. have broken out again. "Whoever looks at South Africa today will conclude that things are not good in the country. Corruption and nepotism, lies and black racism rage in a country which after the end of apartheid stood for the hope

of another Africa, for a continent in which blacks and whites could live in a democratic relationship next to each other and where a still oppressed majority is in the position to guide the fortunes of the country into a framework in accordance with a rule of law. Still, nothing of the like indicates that these expectations are being fulfilled." There hardly would have been the support of appalling dictators in Zimbabwe or in the Sudan under Nelson Mandela. "Still, almost ten years after he left office as South Africa's President, there are more and more signs indicating that the, in the meantime ninety-year-old, was an anomaly."

Zimbabwe (prior South Rhodesia) became independent under the white racist leader Ian Smith in 1965. It lived for 15 years with strict racial segregation until the United Nations forced multiracial elections in 1980. As a result Robert Gabriel Mugabe (b. 1924) came out as a winner, and he immediately transformed the country into a malicious dictatorship. In what was initially an understandable effort to bring about a new distribution of land for the benefit of 'blacks,' the end result was that a large portion of 'whites,' as well as members of all competing tribes, were driven out or killed.

4. The Combination of Racism with other Factors

The Combination of Racism with Religion, Politics, and Language

Racism is often inseparably combined with other types of condemnation and oppression of unwanted groups of people. It is often racism that provides the ideological justification for completely different conflicts, and it is often so that conflicts finally lead to a racist hardening of an existing conflict.

A typical example is the form of anti-Zionism against **Israel** that is a variation of anti-Semitism directed against Jews. This form of anti-Zionism wants to see Israel left without a Jewish state in Palestine, even if a solution for the Palestinians is going to be found. (There are other definitions of anti-Zionism, e.g. rejecting zionistic claims, that all Palestine belongs to Israel according to God's command.) But what is the subject of the hatred in this case? Does it have to do with Jews as a race? Does it have to do with Judaism as a religion in contrast to Islam? Or with the liberal political system of Israel? Is it envy about Israel's economic successes? Does it have to do with the Jews as a race? It stands to reason, because otherwise

the Arabic edition of *Mein Kampf* would not be a bestseller, which by the way renders 'anti-Semitism' with 'anti-Judaism,' because the Nazis naturally did not mean the Arabs, who are likewise 'Semites.' The same combination is naturally found in its opposite form in the attitude of many Israelis toward **Palestinians**.

Or let's take **Turkey** since Kemal Ataturk. Turkey is built upon a strong sense of Turkish nationalism. But is it *religiously* based? Whoever is not a Muslim is not a true Turk, and even non-Sunnite Turkish Muslims such as the Alevites are persecuted. Is it based on *language*? Kurdish, Armenian and Assyrian should be extinguished as native languages. Is it racially justified? Kurds, Armenians and Assyrians are seen as contaminants. It is really all of this together, a nationalism, that should hold the people of the country together. That Ataturk was himself of Albanian descent exemplarily demonstrates – as we have said before –that most often such nationalism has little to do with reality.

The Combination of Racism and Religion (Iraq, Vietnam, Ireland)

There are many examples of the combination of racism and religious persecution. In **Iraq** the long established Christian population is under persecution. The Assyrio-Chaldean and other Christian ethnicities, such as the Armenians, are also opposed. This is because they are a non-Arab minority as well as due to the fact that they are Christians and not Muslims. Out of what used to be 650,000 Christians who had lived in Iraq for almost 200 years, three quarters of them had been driven out of the country.⁷⁴

In **Vietnam** the government is persecuting Montagnards – French for 'mountain dwellers' – in the central Vietnamese highlands, because these people have turned to Christianity in large numbers. These people were pushed into the mountains at the beginning of the 20th century. They are completely cut off from economic development and remain impoverished. Persecuted under the communists, about 2 million Montagnards turned to Christianity. Their fertile land was largely unlawfully allocated to the Kinh Vietnamese. Their faith has aroused the suspicion that they are working for foreign powers. A portion of the Montagnards fled to Cambodia because of expropriation, imprisonment, torture, and the prohibition against practicing their religion.

From 1969 to 1998 Protestant British and Catholic Irish fought violently in **Northern Ireland**, respectively using small armed militia on both sides. The industrialized northeastern areas of Northern Ireland and almost all

larger cities became Protestant, while the rural western areas were dominated by Catholics. The Northeast is more highly industrialized than the rural West. Both groups emerged from long standing Irish, on the one hand, and from Scottish and English settlers who colonized Ireland, on the other hand. The conflict is what determined the course of daily life, caused the separation of residential areas in the cities, and cost almost 4,000 civilians their lives.

The Combination of Racism and Language (Belgium)

An example of the combination of racism with linguistic and economic questions is **Belgium**. The Dutch speaking Flemish (60%), primarily in the north, the Walloons and other French speaking inhabitants, above all in the south and in Brussels (40%), the German-speaking minority in the east, as well as the capital Brussels in the center with two official languages, are actually only held together by the crown. In spite of advancing decentralization since the 1970s, and the transformation of the country into a federal state in 1993, conflicts and national crises have not come to a halt. Since the collapse of the mining industry, the French-speaking part is significantly poorer. This is a reason there is a strong separatist movement among the Flemish, one that would avoid 'feeding' the Walloons any longer.

It is interesting and at the same time typical that the alleged ethnic conflict is considered to have begun at the earliest with the founding of the Kingdom of Belgium in 1830, when actually it occurred at the end of the 19th century when the Flemish in French-speaking Belgium rediscovered their Dutch language. Up to that time, French had been the language of education for all people.

Justification of Racism with Religion (India)

In his *History of Racism*, Imanuel Geiss views the Indian caste system as "the oldest form of quasi-racist structures," which began at the latest with the conquest of Northern India by the Aryans around 1500 B.C. "Light skinned conquerors forced dark-skinned subjects as 'slaves' into apartheid in a race-caste society, which could not be held in its original form, but led to an extreme fragmentation and sealing off of life into separated castes for many matters related to vocation, place of residential, eating, and mar-

riage."⁷⁷ The conference on anti-racism held by the United Nations in Durban (South Africa) in March 2001 vocally condemned racism on the basis of the caste system as apartheid, but it did not lead to any formal resolution against India.

It is astonishing that this type of religiously based racism has continued in India for 3,500 years. We will limit ourselves to the lowest class in the caste system and not take into account that in India, in opposition to the constitution, many 'scheduled tribes' are neglected and spurned.

'Dalit' is the self-designation of the descendents of original Indian inhabitants, who for racist reasons were excluded as 'untouchables' ('pariahs') from the caste system of the militant indo-European conquerors. In our country they were often incorrectly referred to in earlier times as 'casteless.' The number of Hindu Dalits is estimated at 240 million, of which 160 million are Hindus, and the rest Buddhists and Christians, that is, almost one quarter of the Indian population. Up to the present they are discriminated against by Indians belonging to various castes, scorned, exploited, held as slaves, beaten, deprived of their possessions and their land, and forced to conduct the lowest forms of work. Women are often in part even publicly raped without any consequences. Presently, 800,000 Dalits in India have to empty latrines with their bare hands.

Admittedly the 1949 constitution of the Republic of India forbids discrimination on the basis of caste and ethnicity. However, in practice, all such measures have had little success. In 1956 B. R. Ambedkar (1891-1956) initiated a mass conversion of Dalits to Buddhism, and additional mass conversions to Buddhism and Christianity followed. However, this only worsened the situation of the Dalits, especially since Dalits stop receiving social welfare as soon as they have officially become Christians.

III. The Situation in Germany

1. Gypsies

Since the 15th century, the German term *Zigeuner* ("gypsy") or a similar term in all other European languages (e.g., French *tsigane*, Italian *zingaro*, Turkish *cingene*) has designated a widely fragmented group of approximately 15 million people. This group consists of immigrant peoples, Roma and Sinti, who came from India over the Balkans to Europe in the 14th and 15 centuries. In addition to them, there were smaller European groups such as the *Jenisch*, who lived with the Roma and Sinti or had a similar lifestyle.

It is presumed that in the 9th to 11th centuries these peoples were displaced by Arab conquerors from Punjab in India and used as soldiers and slaves in the Eastern Roman Empire. After that they moved out of Turkey into the Balkans. The history of the Zigeuner ("gypsies") is a thousand-year story of racist disdain and oppression on almost all continents.

The first persecution of the gypsies is known to have come from the Romanian Wallachia and Moldavian principalities, where from the 14th until the 19th centuries Roma were enslaved, imprisoned, displaced, and segregated. The disdain for gypsies is still strongest there, and it is recognizable in the pogroms that occurred at the beginning of the 1990s shortly after the fall of the Berlin Wall.

Until approximately 1500, gypsies lived largely unmolested in the rest of Europe, especially since migrations were also widespread among other people groups. In 1498 the imperial princes and bishops at the Imperial Diet at Freiburg declared that all *Zigeuner* were spies for the Turks and enemies of Christianity. For that reason they were condemned. This was a one-off event in German legal history prior to National Socialism that fed on the hysterical fear of Turks. It is also a classic example of how racism develops.

In the 18th and 19th centuries *Zigeuner* was a defining term by the police, which was used in laws and ordinances against 'vagrant peoples.' Since more than 90% of Roma were settled down in Europe (not wandering), they were not much in evidence. It was the small portion of such people, who crossed borders in wandering groups, that came into people's field of vision. Since 1871 German law has spoken of the 'gypsy menace.'

In the 19th century the idea had spread so much that Roma were a group that belonged together racially and lived from theft and deception that immigration into the United States of America and Latin American countries

was forbidden in 1880 and 1885. By the way, even in Malta and Denmark, where there are no 'gypsies,' a good portion of the population oppose 'gypsies,' as a recent European Union study has shown.

For decades there has been a refusal to speak about the genocide of 300,000 Roma and Sinti during the Third Reich, even after the fact of the genocide of Jews had long been accepted. The German Federal Supreme Court still ruled in 1956 that the persecution of gypsies under National Socialism was not racist in nature, but rather was aimed at the "asocial characteristics of the gypsies."

Roma range from light skinned to dark skinned – sometimes within the same family – and at the same time they can consist of Orthodox, Catholics, Protestants, Muslims, Jews, and atheists. For outsiders, some of them are easily identified because of their skin color and are stopped at borders. Most of them, however, are not able to be differentiated from other Europeans.

In Germany the Central Council of Sinti and Roma disapproves of the designation 'gypsy' because of its ideological liability and its use in the Third Reich, while the less representative Sinti Alliance of Germany comes out for a 'value neutral' continued use of the term.

2. Anti-Semitism

The first anti-Semitism was found among the Greeks and Egyptians beginning in the 3rd century B.C. The "Invention of Judaism as a race in 1492"⁷⁹ took place in Spain, where Jews who converted to Christianity were nevertheless harshly persecuted due to alleged deception and conspiratorial intentions. Judaism was now no longer a religion but rather an indication of ancestry. After a long development, Eugen Dühring (1833-1921) drew the conclusion: Jewish baptism is not the solution, because it is not a question of religion, but rather of 'race' or 'race harmfulness,' respectively. It is hardly surprising that churches did not even stand up for and defend baptized Jews.

The Swiss government writes in this connection: "The term anti-Semitism, which was coined by Wilhelm Marr in 1879, designates enmity against Jews, who are construed and perceived as a homogenous 'race.' The development of such a racial term occurred in the course of the 19th century against the backdrop of an increasingly scientific approach as well as a decline in religious interpretations. Racist anti-Semitism is superim-

posed upon historical anti-Judaism, which goes back a long way and stands for the religiously characterized enmity toward Jews . . . what is viewed as unalterable and fixed features of differentiation and stereotypes relating to the 'Jewish race' were used from then on as an instrument of segregation and discrimination. The anti-Semitism that came up in the 19th century in bourgeois circles as well as in the working class was in the first place a reaction to the entry of Jewish citizens into the social and political life of (Western) Europe . . . Features of anti-Semitism are the notion of a 'Jewish world conspiracy' and the fact that 'the Jews' have to be held out as the scapegoats for social, political, and societal evils."⁸⁰

Nowadays European anti-Semitism primarily consists of some forms of anti-Zionism directed against the state of Israel (but see p. 65!) or in the continuation of the idea of Jewish conspiracy theories that have to be held out repeatedly to explain the appearance of anti-Semitism. It is thus parroted that Christians were forbidden to conduct money lending and for that reason the Jews took this line of business and became unpopular as a result of their involvement in it. Still, the picture of the Jewish 'usurer' arose at the end of the 14th century and the beginning of the 15th century after the grand epoch of international Jewish money dealing had long ended. In England the Jews had been displaced or driven underground as early as 1290 by the King. The advent of anti-Semitism did not cause any interruption in this. And in the 600 years since 1400 surely no one has analyzed whether actually it was only Jews who were allowed to lend money or whether other alleged historical truths about Jews are actually backed by any evidence.

3. National Socialism

The Uniqueness of Racism in the Third Reich

In the morning hours of June 6, 1941 Hitler attacked the Soviet Union "with the biggest fire storm of all time and with the strongest offensive armed force in military history." Under the disguise of a horrible war for Lebensraum (living space) in the East, millions of Jews, gypsies and other 'non-Aryans' were killed. Hitler and his myrmidons put their racist worldview into practice in the shadows of war as an extermination, a 'Holocaust.' The 'Aryan' racism, along with anti-Semitism and anti-Gypsyism

has its roots in almost all European cultures, but it finds its bloody consummation in 'Germanic' racism. "Hitler only had two true goals, one relating to foreign policy and one relating to racial policy. Under his rule, Germany had to conquer new areas for living space in the East, and he had to remove the Jews. The state and its constitution, domestic, economic, and social policy, the party, their program and their ideology – everything was a means to this dual end."⁸²

National Socialism was in its racism and genocide uniquely abominable. "I maintain . . . that the national socialistic murder of Jews was unique because never before had a nation decided and announced via the authority of its leader in power that a particular group of people including the elderly, women, children, and infants was to be killed off as completely as possible and that this resolution was to be put into action with all possible state instruments of power."⁸³

Something else differentiates National Socialism from most racist systems. While for instance the Indian caste system, the enslavement of black Africans by Arab lords, the apartheid in South Africa, or racial segregation in the southern part of the Unites States provided respective ideological justifications for a longstanding power structure, National Socialism built upon centuries-old prejudices and not on an actually present separation of society into Jews and non-Jews, apart from the Sinti and Roma. Jews were fully integrated into society and racial differentiation was not self-evident.

Hitler's Race Religion

"The core of the National Socialist worldview... has been oft described. According to this worldview, history is a story of racial wars. The blond race is called to rule over the earth as the 'highest image of the Lord;' and yet the race sees itself under growing pressure from the inferior mixed breed races, in particular the Jews, which threatened the world with subjugation and destruction as the largest opposing force... On the one hand, it is not only a historical mandate to fight and bring liquidation, but, on the other hand, it was a mandate to maintain the costly basin of Nordic blood via breeding and racial hygiene that would have the consecration and

legitimization of a divine command since it would fulfill the plan of creation . . ."84

That Hitler directly combines God with a social Darwinistic fight for survival upon a racial ideological base, 85 which is seen most clearly when he refers to the 'Creator' (and similar expressions) . . . The German people received from the Creator the 'mandate' to reshape the world, for a "historical revision of unique proportions was given to us by the Creator."

When Hitler mentioned that "God [has] given me my blood," he did not mean, or at least he did not mean primarily, his creation as an individual being, but rather the creation of Aryan or German 'blood,' i.e., the blood of the race or of the people. That which God has created can for that reason only be a "commandment from God." Also, on account of this, racial egoism may "not be seen as not well-pleasing to God," since if God had not desired the involvement of the German race, "God [would not have] created me as a German." Whoever "destroys [God's] work" destroys the "creation of the Lord" and with that "declares war . . . on God's will."

The mixing of the races is, hence, the quintessential 'sin' against creation. However, Christianity is also rebellion and "protest against the creation," insofar as it rejects the necessity of killing in the fight for survival and, for instance, also rejects euthanasia. Christianity's lack of focus on race puts it into a position of opposition against the Creator, for instance when missionary work leads to accepting 'inferior' people. For Hitler it is a sin against the will of the eternal Creator, . . . if hundreds of thousands . . . of his most well gifted beings decay in the present day proletarian quagmire, while Hottentots and Zulu kaffirs are trained up for . . . church vocations."

It can be assumed that the connection between thinking about theistic creation and biological evolution, in the sense that God created the fight for survival, was not a feature distinctive to Hitler. Rather, it was something that was in circulation at his time in various forms. The odd mixture that came into play with Hitler, one of enlightenment and the priority of science, along with belief in God and the God-willed fostering of the evolution of the races, was at that time to some extent in the air, even if it cannot alone explain why this combination had such brutal consequences for Hitler and not for other theistically enlightened social Darwinists.

4. Right-wing Extremism in German-speaking Countries today

Right-wing Extremism in Germany

The University of Leipzig has repeatedly conducted surveys for the Friedrich Ebert Foundation, which is closely allied with the German SPD political party, regarding the spread of right-wing extremist attitudes. 86 The numbers are reproduced below, although they are not significantly meaningful.

What is there to criticize about such numbers and almost all similar investigations? There are three questions that relate to each of the five topics, but a positive answer to each question could just as easily be given by a left-wing extremist. Absurd charges against Jews are not only found in the rightist camp. It is not only right-wing extremists who want a dictatorship and a strong man. Social Darwinism is also a component of the Marxist worldview. The German politician Oskar Lafontaine has gone hunting for votes with references of hostility to foreigners and alleged domination by foreign influences. Additionally, some of the questions are asked in a manner that, taken by themselves, naïve citizens would agree with, for instance when a question is asked as to whether Germany receives too little attention in international politics.

It has been shown from the many surveys that only have to do with right-wing or left-wing extremism that they are always one-sided. When both are polled and analyzed together, the analyses are senseless.

It is to be briefly noted at this point that the fight against racism is made more difficult when one only assumes it is a matter suspected of a political opponent. Without wanting to constrict the fight against right-wing radical racism in one way or another, racism can be bound together with each and every political ideology, with leftist political positions and left-wing extremism. Oskar Lafontaine's racist statements regarding Poland and Southeast Europe demonstrate this in a relatively harmless example, while the Soviet Union's imperialism and the Marxism of the 'white' hater Robert Mugabe exhibit are its violent outgrowth.

While there are hardly any reliable numbers available as to how many Germans have racist or right-wing extremist attitudes, and most truly high numbers only come from the political left, the numbers of active racists and right-wing extremists look more reliable. This is due to the fact that in Germany, surveillance of right-wing extremism is the task of the offices of constitutional protection of the states and of the federal government, which is independent of whether it is the CDU/CSU parties or the SPD party that heads government. In these cases, similar results have been found over longer periods of time.

According to the 2007 report on constitutional protection published by the German Interior Ministry, there are presently 4,400 neo-Nazis as well as 14,200 members in the right-wing extremist NPD (National Democratic Party of Germany) and DVU (German People's Union) parties, and there are an additional 4,000 in other right-wing extremist organizations. From all of these groups a total of 10,000 right-wing extremists are categorized as violence-prone. All told, about 1,000 violent acts are committed by them annually, and most of them involve beating up and injuring foreigners or dark-skinned Germans. There are 1,000 right-wing extremist websites and several small publishing houses. The major medium of dissemination of such attitudes is right-wing extremist music.

Admittedly the distribution of those voting for the NPD and DVU parties varies strongly from region to region. In the September 18, 2005 elections for the German *Bundestag* they received 1.6% of the vote, but seen regionally the results range from 0.1% to levels that gain the NPD and DVU seats in local or state parliaments. In Sachsen the NPD party received 9.2% of the September 17, 2004 vote, or 12 parliamentary seats, and 7.3%, or 6 parliamentary seats, in the September 17, 2006 elections in Mecklenburg-Vorpommern. The DVU party received 6.1%, or 6 representatives, as

a result of the election on September 19, 2004 in Brandenburg (the two parties never run against each other simultaneously).

What is it that right-wing extremists want? The report on constitutional protection concisely states and substantiates with numerous pieces of documentary evidence the following: "The right-wing extremist worldview is shaped by nationalistic and racist outlooks."87 In addition there are two elements, which show right wing extremism to be a child of National Socialism. Those elements are political centralism and anti-Semitism. "As a general rule, right-wing extremism advocates an authoritarian political system, in which the state and the people, according to their notions of an ethnically homogeneous state as an alleged natural order, fuse into unity. According to this ideology of a 'national community,' the national leader should intuitively act according to the supposed uniform will of the people."88 "Anti-Semitism remains the central ideological link between the diverse currents of right-wing extremism. This pertains above all to an anti-Semitism of insinuations, which, in addition to overt anti-Semitic agitation, has increased."89 As evidence there is a statement by the NPD which is quoted: "The USA's foreign policy is made in Tel Aviv. In light of the agitation against Germany and the German people coming from Jewish circles, the USA, as an ally, is consequently more than dubious."90

Right-wing Extremism in Switzerland and Austria

Admittedly there are annual reports regarding extremism published annually in Switzerland and Austria. They are the "Report on the Internal Security of Switzerland" by the Service for Analysis and Prevention (DAP, or *Dienst für Analyse und Prävention*) of the Federal Office of Police and the constitutional protection report published by Austria's Federal Ministry for the Interior and its Federal Office for the Protection of the Constitution and Anti-Terrorism. However, in both countries it is not permitted to observe right-wing extremist organizations *per se*, as long as they are not demonstrating any violent activity. For this reason there are no precise numbers available from either of these countries with respect to the right-wing scene.

In Switzerland it is mostly only the violence-prone skinheads who are associated with right-wing extremism. The Federal Police estimate that

there are 1,200 right-wing extremists and 800 sympathizers. Right-wing extremist parties in Switzerland are designated as 'nationally conservative' or 'conservative right.'

Right-wing parties in Austria are also legal, such as the FPÖ (Freedom Party of Austria, or *Freiheitliche Partei Österreichs*) which recently won an enormous proportion of the votes in federal elections. They are not monitored, and only neo-Nazism is criminally forbidden by law. In Austria it is also primarily the violence-prone skinhead scene that is considered right-wing extremist.

Excursus: The 'People' as a divine Order in Creation?

For many Christians 'the people,' in the sense of an ancestral community, possess a quality instilled by God that is found as well in areas such as family, church, work/commerce, and the state. However, while we find clear evidence in the Bible that God created the four named institutions, that he desires them, and that he confers authority upon them for certain tasks (e.g., Genesis 1:26-27, Romans 13:1-7, Ephesians 1), we do not find this anywhere with respect to the institution of 'the people.' Peoples emerge in the Bible, on the one hand, because people have children, but also because there is mixing via marriage, migration, and as a result of war.

If there is any sort of special people for Christians, then it is the Jews. God says that on no account did he choose Israel because it was something special (Deuteronomy 7:7-8). In addition, he furthermore did so in order to bless the world (Genesis 12:1-3) and not to harm it. And even for Israel what applied and applies is that it is not defined via biological ancestry but rather by its faith and its common history. Already in the Old Testament there were parts of ancestral line that broke away from the people of Israel, became 'lost' with respect to Israel, and developed their own history and culture (e.g., Esau and his descendants). Additionally, there were many a non-Jew who through conversion became full-fledged Jews (e.g., Moses' in-laws, Rahab the prostitute and her family, and Ruth).

What applies in light of the failure of many Christians at the time of National Socialism is the following: "The only response is – and Evangelical Christians have a holy responsibility to proclaim it without fear or partiality – is that no nation possesses the quality of salvation and that all peoples and all individuals are judged according to the exact same divine standard of righteousness . . ."⁹¹

There is no biblical justification for the classification of a racially and biologically defined people as its own authority structure and next to the state as a divine order of creation, one which is next to and delimited to the state. The state, as a general rule, always harbors at least some citizens of completely different ancestries. Along with Karl Barth I oppose the "elevation of the term 'people' to the level of theo-ethical main concepts," so that the people suddenly and allegedly become a 'divine order in creation,' such as the family. God gave the state the monopoly of power, the church the 'preaching monopoly,' and the family the 'child-rearing monopoly.' A biological 'people' has no authority over anyone. In fact, there is no such thing in the first place as a 'people.' Practically all the people of a nation are, historically viewed, a mixture of people. And to begin with, a mother tongue has nothing to do with racial affiliation. It is even often the case that numerous peoples speak the same language or that there are numerous languages found within one people.

"I have a dream that one day this nation will rise up and live out the true meaning of its creed: We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights that among these are Life, Liberty and the pursuit of Happiness." King Jr. fought racism in America.

In 1924 B.R. Ambedkar (Ph.D., Economics, Columbia University, and D.Sc., London University), a Dalit, returned to India. He received no merit nor was any honour accorded to him. Instead, he was exposed to ugly opposition, relentless intellectual criticism, and caste-bound cultural humiliations. On Christmas Day 1927, Dr. Ambedkar publicly burned Manu Smiriti, the most sacred and basic document Brahmins used to justify caste and ascribe untouchability. Says Manu, the ancient lawgiver of brahmanical tradition, "When a Brahman is born, he springs to light above the world; he is the chief of all creatures, entitled by eminence of birth to the wealth of the world" (Manusmriti.I.98-100). Dr. Ambedkar fought casteism in India.

"Had Ambedkar not learned English, he would not have gone abroad," said Eash Kumar Gangania, "and had he not gone abroad, he would not have become Babasaheb for us." Ambedkar became the Father of the Indian Constitution. Gangania, a teacher from Delhi, was speaking to 1,500 Dalits in a remote village of Bankagaon, in UP. The crowd was rapt as Gangania added that it all happened "because Ambedkar learned English," finally ending with a powerful and surprising message: "If you learn English, you, too, can scale the heights Babasaheb did." Gangania's speech came on a special occasion, 30 April 2010, the day Bankagaon's Dalits pledged to learn the English language as well as worship it as a goddess. It was the day they laid the foundations of a temple dedicated to "English, the

Dalit Goddess." The Dalits' quest for English is their attempt to find a voice. It has all the ingredients of an epic struggle. This goddess may not join the Hindu pantheon of 330 million, but it could usher in an era of cultural rejuvenation for Dalits.¹

The caste system is based on the principle of discrimination and inequality. It is one of the most rigid and institutionalised brutalities of Hindu society. While the agenda for political freedom of India from British rule was achieved in 1947, the freedom to emancipate the masses from perpetual exploitation and oppression remains to be won. Phule, Ambedkar, and Periyar continued to advocate that "a society divided by social oppression could not constitute a genuine nation."

Ontological Basis for Caste

The *Purusha Sukta* is an important part of the Rig-Veda (10.7.90.1-16). This hymn is recited in almost all Vedic rituals and ceremonies. According to this hymn, from the body of Brahma come the four main categories of Hindu society, namely the four *varnas* or castes: From His face (or the mouth) came the *Brahmans*, the priests. From His two arms came the *kshatriyas*, the warrior. From His two thighs came the *vaishyas*, the businessman. From His two feet came the *shudras*, the servants. Caste system thus has ontological value.

The untouchables are born from outside the body of the Creator, almost a different species from Brahma's children. Their entry into the divine body would be as unthinkable as the entry of an animal. The word "Dalit," meaning "crushed underfoot" or "broken into pieces," is the contemporary version of the word "Untouchable."

The Ritual Purity and Pollution

Many status differences in Indian society are expressed in terms of ritual purity and pollution. Reflecting on the opposition between "the pure and the impure" in his classic exposition *Homo Hierarchicus*, Louis Dumont has argued that this binary opposition is the ideological principal and the essence of the caste system.³ Notions of purity and pollution are extremely complex and vary greatly among different castes, religious groups, and regions. However, broadly speaking, high status is associated with purity

and low status with pollution. Some kinds of purity are inherent, or inborn; for example, gold is purer than copper by its very nature and, similarly, a member of a high-ranking Brahman, or priestly, caste is born with more inherent purity than is a member of a low-ranking Dalit. Unless the Brahman defiles himself in some extraordinary way, throughout his life he will always be purer than a Dalit. Other kinds of purity are more transitory – a Brahman who has just taken a bath is more ritually pure than is a Brahman who has not bathed for a day. This situation could easily reverse itself temporarily, depending on bath schedules, participation in polluting activities, or contact with temporarily polluting substances.

Purity is associated with ritual cleanliness – daily bathing in flowing water, dressing in properly laundered clothes of approved materials, eating only the foods appropriate for one's caste, refraining from physical contact with people of lower rank, and avoiding involvement with ritually impure substances. The latter include body wastes and excretions, most especially those of another adult person. Contact with the products of death or violence is typically polluting and threatening to ritual purity.

A Brahman born of proper Brahman parents retains his inherent purity if he bathes and dresses himself properly, adheres to a vegetarian diet, eats meals prepared only by persons of appropriate rank, and keeps his person away from the bodily exuviate of others (except for necessary contact with the secretions of family infants and small children). If a Brahman happens to come into bodily contact with a polluting substance, he can remove this pollution by bathing and changing his clothing. However, if he were to eat meat or commit other transgressions of the rigid dietary codes of his particular caste, he would be considered more deeply polluted and would have to undergo various purifying rites and payment of fines imposed by his caste council in order to restore his inherent purity.

In sharp contrast to the purity of a Brahman, a Dalit born of Dalit parents is considered to be born inherently polluted. Touching his body is polluting to those higher on the caste hierarchy than he, and they will shrink from his touch, whether or not he has bathed recently. Dalits are associated with the traditional occupation of cleaning human feces from latrines and sweeping public lanes of all kinds of dirt. Traditionally, Dalits remove these polluting materials in baskets carried atop the head and dumped out in a garbage pile at the edge of the village or neighbourhood. The involvement of Dalits with such filth accords with their low-status position at the bottom of the Hindu caste hierarchy, even as their services allow high-status people, such as Brahmans, to maintain their ritual purity.

However, castes associated with ruling and warfare – and the killing and deaths of human beings – are typically accorded high rank on the caste hierarchy. In these instances, political power and wealth outrank association with violence as the key determinant of caste rank.

Ideology as an instrument of domination, of ensuring that the common people think and behave as the ruling elite want them to, finds an archetypical expression in Brahmanism. Brahmanism stands for the aggregate of the sacerdotal literature, social structure, and religio-political institutions that has been masterminded by the elite with the primary aim of keeping the masses ignorant, servile, and disunited. Brahmanism uses the ideology of caste as a crucial instrument to dehumanize, divide, and dominate the productive majority. Different caste groups are separated from each other in matters of marriage, physical contact, and food by rules of purity and pollution. Hierarchy, along with purity and power, culminates in the Brahman. Power politics thus is at the heart of Brahmanism. The exercise of power necessarily involves conflict and resistance. The contestation for economic, cultural, and intellectual resources between the powerful and the powerless involves both dominance and resistance.

The Strangers Face

When two Indians meet as strangers, "the encounter is often a duel, everything – response, behavior, body language, social niceties, form of address, receptivity – depends on an assessment of where the person stands on the scale of power and influence." For an Indian, superior and subordinate relationships "have the character of eternal verity and moral imperative – (and the) automatic reverence for superiors is a nearly universal psycho-social fact." The entire worth of a person is dependent on the position he occupies on a hierarchical scale. In Hinduism, identity is dependent upon worth, and worth is determined as people are born and reborn in accordance with their *karmas*, the quality of their deeds. This certainly affects human relationships.

Resistance to Caste

Despite resistance to caste and Brahmanism, beginning with shramanic heterodoxies and Buddhism, followed by various streams of Bhakti movements, Sikhism, Sufism, similar lesser known campaigns and ideologies

and anti-caste egalitarian movements in modern India, caste consciousness and Brahamanic mindset persist in their modernized, metamorphosed avatar, defying and denying democratic ideals.

The Bhakti movement that emerged in the fourteenth and fifteenth centuries, exemplified in the cults of popular "saints" such as Kabir and Mirabai, tried to negate the power of the Brahmin clergy and questioned the Brahmin's chief weapon: purity and the power to dispense untouchability.

It's all one skin and bone, one piss and shit, one blood, one meat. From one drop, a universe. Who's a Brahmin? Who's shudra?

So sang Kabir, the fifteenth-century Bhakti saint (Hess, 1983: 25). Yet the Bhakti movements were unable to change the workings of the caste system, primarily because these saints formed a sort of mystic fringe, spiritually intense alternatives to the main body of orthodoxy that, although popular and doctrinally seductive, were no threat to a 3,000-year-old institutionalised discrimination.

In the nineteenth century, social reform emanated from the educated upper-caste elites who came into contact with Western ideas of liberalism and rationality (Raychaudhuri, 1999: 60). There were campaigns to secure the rights of the widow, to ban sati (the practice of widows immolating themselves on their husband's funeral pyres), and to reject caste.

The emergence of Gandhi and Ambedkar – mutually opposed to each other, yet highly significant, each in his own way, to the cause of the Dalits – grew from the context created by these nineteenth-century movements as well as the deeper traditions of anticaste protests created by Buddhism, Jainism, and the Bhakti cults. The movement to abolish caste prejudices owes its modern liberal humanist form to Jotirao Govindrao Phule in Maharashtra and later to the campaigns of E. V. Ramaswami Naicker in Madras state.

Jotirao Phule (1827-1890) developed powerful arguments against the caste system and the Brahman and also used Christian missionary arguments to "reject the fictitious world of Hindu religion" (O'Hanlon, 1985: 105). His Satyashodhak Samaj or "Truth-Seeking Society" gave voice in 1873 to the radical idea that Brahmins had used religious authority and administrative power acquired under colonial rule to oppress other sections of society. Although "moderate" and "respectable" reformers were reluctant to accept such wholesale condemnation of Brahmins (O'Hanlon, 1985: 255) and the Satyashodhak Samaj remained virtually limited to the state of Maharashtra, the influence of its ideas can be traced to the anticaste ideologies that emerged subsequently.

The work of Christian missionaries also functioned as a fundamental challenge to traditional caste-based practices. From O'Hanlon's thesis on the radicalizing influence of Christianity on Phule's thoughts, it would be accurate to say that caste, as a conceptual category, was seriously challenged only after the arrival of Christian missionaries, who initiated the radical idea of extending education to the Dalits. The first special schools for Dalits were opened in the 1840s, encouraged not only by the missionaries but also by the British administration. From these schools came the first generation of Dalit activists, writers, and politicians. A Dalit writer recently wrote that as far as the Dalits are concerned, "the British arrived too late and left too early," a reference to the fact that had it not been for the British colonial administration, Dalits would never have gained the right to attend school.⁶

Even though the overwhelming majority of Dalits in the colonial period remained railway workers, landless migrant labourers, urban sweepers, stone cutters, and servants, some became soldiers in the army of the East India Company, and others, such as the *Mahars*, were able to achieve the status of wealthy and assertive elite⁷

After Phule, the other social reformer who can be seen as a precursor of Ambedkar was E. V. Ramaswami Naicker (1879-1973). Naicker founded the Self-Respect Movement, which advocated a vigorous attack on caste, especially "Aryan Brahmins." He campaigned for forcible temple entry, burning of the Manusmriti, and atheism. Ironically, modern-day political parties such as the Dravida Munnetra Kazhagam and the All India Anna Dravida Munnetra Kazhagam, which are the descendants of the Self-Respect Movement, have veered away from the rationalism and atheism of Naicker and instead have lapsed into various forms of Hindu obscurantism. Both Phule and Naicker, however, positioned themselves as not just anti-Brahmin but as implacably anticaste and pro-poor.

The Dravida Munnetra Kazhagam and the All India Anna Dravida Munnetra Kazhagam, political parties that rule the state of Tamil Nadu, were born from Naicker's Self-Respect Movement. Today they openly ally with religious groups and have created a ritualized hero-worshipping political culture by which political leaders are viewed as gods and indulge in a range of superstitious practices.

Intolerant Society

Although Indian society advocates toleration while maintaining an otherwise intolerant cruel society, who can leave the caste hierarchy and claim the benefits of toleration? Who can vertically challenge and aspire for the higher caste in the hierarchy and expect accommodation? The characteristics of "accommodation" to be found in a holistically conceived hierarchical society are not the same as those which will bring about a liberal egalitarian society.⁹

Religious intolerance is not alien to Hinduism. Romila Thapar notes "the nineteenth-century myth that the Hindus are by instinct and religion a non-violent people" and comments, "The genesis of this myth was partly in the romantic image of the Indian past projected, for example, by scholars such as Max Muller." In Hindu tradition, for instance, the mythical battles in Mahabharata and Ramayana epics are frequently used as metaphors for present-day struggles. Writing about "The Mahabharata Legacy, and the Gita's Intent," Rajmohan Gandhi says, "Proud as we are of the epic's codes of chivalry, we cannot be proud, I suggest in all humility, of the story, or history, it reveals. In particular, we cannot be proud of the epic's acquiescence in triumph of revenge over reconciliation. I suggest, further, that we cannot be glad that the epic is reproduced in varied forms in our history" 11

Vengal Chakkarai, a high-caste Hindu convert to Christ, advocated that the church should "confront Hinduism on the plains of life." By this he meant confronting the caste oppression and exploitation. The household of Jesus Christ is duty-bound to spread social equality; the practice of caste divisions in the church runs counter to the teachings of Jesus Christ whose apostle said, "There is neither Jew nor Greek, slave nor free, male nor female, for you are all one in Christ" (Galatians 3: 28). Chakkarai believed that as a result of education in Christian institutions, people gained some understanding of Christianity, but very few made any overt move to Christianity. He wrote in 1913 "that as a matter of historical record, most educated Hindus who had become dissatisfied with their ancestral faith had

been diverted to the neo-Hindu religious movements or theosophy rather than Christianity." He, as we saw earlier, advocated the critique of life, when he stated that it is upon "the plain of life and its struggles that Christianity must confront Hinduism." This could be discerned in the area of social concern, particularly in such matters as caste distinction, dowry, and the needs of the poor. The social reform movements within Hinduism may have been promoted by Christian teachings either by way of reaction or inspiration Gopal Hari Deshmukh attacked many aspects of traditional Indian life – the caste system, child marriage, and the treatment of widows were particular targets. But in his personal life he did not break with traditional ways.

M. M. Thomas writes: "Considering the fact that the Christian Mission was the first in many parts of India to treat the untouchables as human beings and to bring them the gospel of their dignity in Christ, as well as education, Christianity has played a part in arousing and strengthening Anti-Brahmanism. And this in turn awoke the Brahmin and other caste Hindu leadership to the need of putting the Hindu household itself in order by social and religious reform ... fear of Christianity has been the beginning of social wisdom for Hinduism."

Democracy and Caste

How could democracy, brought in by British rule, flourish in a highly hierarchical Hindu society, promoting the ideal of egalitarian society? This appears to be an enigma. The Indian response to this democratic ideal of an equal society must therefore be seen in the specific and unique context of its own culture and tradition.

Pavan K. Varma argues in his book that "democracy has survived in India not because Indians are democratic, but because democracy has proved

to be the most effective instrument for cherished pursuit of power." 17 In fact, Varma builds a case that the Hindu society "exalts the pursuit of material well-being, Aretha, as a principal goal of life." A significant thought that he sums up is, "Indians are extraordinarily sensitive to the calculus of power. They consider the pursuit of power a legitimate end in itself and display great astuteness in adjusting to, and discovering, the focus of power. Those who renounce the lure of power are worshipped, not because their example is capable of emulation, but in sheer awe of their ability to transcend the irresistible." 18

Answering the question why Gandhism failed in India, Varma states, "Mahatma Gandhi believed that the means are as important as the end. His creed failed to attract followers because the concept was alien to Indian tradition. India's most well-known treatise on statecraft, the Arthashastra, written by Kautilya almost two thousand years ago, wastes little time on moral underpinnings of power. On the contrary, it advocates a compelling unsentimental recipe on how to seize power through means fair and foul. Kautilya's essential thesis is that expediency is far more important than conventional morality in conducting the affairs of the state."¹⁹

Democracy has flourished in India because most Indians have perceived it to be a pragmatic and effective means to personal power by participating in the democratic process.²⁰ In the past, status was prescriptive, a consequence of one's birth. Today it can be acquired by other means, including greater avenues of upward mobility. But this has not made people more egalitarian in their outlook. In a country where resources are scarce and opportunities for upward mobility are limited, political power opens the gates to both.²¹

The hierarchical frame of mind of the Hindu society has not been replaced by a new egalitarianism; rather, democracy provides legitimacy to hierarchies, both old and new. Varma argues that "democracy did not adopt India. Indians usurped democracy because it could be moulded to fit earlier structures without threatening them. The miracle of India is that the practice of democracy has flourished within its boundaries for over five decades in the absence of a democratic temperament."²²

Democracy has led to gradual but genuine political empowerment of the weakest and poorest sections. Socially the lower castes have continued to rise through the ballot box and the growing literacy. Local self-government in the form of Panchayati Raj has slowly become a reality, thanks to the Seventy-Third Amendment to the constitution in 1993.

Caste Divisions in Church

Caste thinking is in some of our churches. Many scholars have documented it. Anantha Krishna Iyer, outlining the caste-oriented manners and customs of Syrian Christians, writes, "Each division among the Syrian Christians has become, as in Hindu caste, an endogamous sect, with no intermarriage between the members of one sect and those of another, though no objection is made to inter-dining." 23 It is not uncommon that high-caste Christians demand separation, for fear of pollution, from the Christians of Dalit origin.

The Christians of Dalit origin speak of triple discrimination of which they are victims. First, they are denied their government-instituted reservation privileges when they publicly declare their allegiance to Jesus Christ. Second, they encounter discrimination in the Church. Third, the high caste uses the Dalits to persecute the Dalits who turn to Christ. Dumont himself recognized the existence of caste among non–Hindus as due to "the proximity of the Hindu environment, which predominates both generally and regionally."²⁴

Conversion to Christianity still disqualifies poor and underprivileged converts from Dalit benefits.²⁵ Religion should not become a disqualifica-

tion. Social and economic conditions should determine the granting of privileges. The Dalit Christians have long demanded reservation benefits from successive governments in power at New Delhi, but in vain. The demand is called controversial, and fears are expressed that if Dalit Christians are given reservation benefits, non-Christian Dalits will leave the caste hierarchy of Hinduism and convert to Christianity.

Survival of Caste

This question has been debated several times over for a century and a half. Various voices address this question. Harold Gould writes, "It ... appears very unlikely that so admirable an adaptive structure as caste is in any serious danger of ever disappearing completely." N. Jayaram holds this opinion: "Its religious basis may wane, its systemic rigor may weaken; but its social (kinship) basis will persist, and its group connotation will gain strength. As far as its interface with Hinduism is concerned, though Hinduism may lose meaning as a justificatory ideology for the hierarchy and inequalities of the system, its cultural crux will persist and crystallize. And, Hinduism will benefit more from the survival of caste than caste from Hinduism."

However the Dalits have a different approach to caste system, which is succinctly summarized by Bhagwan Das, who challenges the dehumanizing caste identity as he writes: "Upper caste Hindus has a vested interest in maintaining and perpetuating caste. If caste goes, Hinduism will die. With the Dalits it is just the opposite. Caste is the greatest obstacle in the way of their unity and progress. If they do not destroy caste, caste will destroy them. The Hindus have no real sympathy with them. They need them only to do dirty work and to render them friendless by pitting them against the Muslims one day, against Sikhs the next day and maybe against the Christians very soon." He proposes that "in the eradication of caste and adoption of the right code of conduct based on equality, compassion, loving kindness, and justice lies their salvation." The laudable list of transforma-

tional values that Bhagwan Das has proposed, and that he has observed, are not part of Hindu culture.

Economic projects as such do not help poor people develop the crucial sense of self-worth. Rather, the development of self-worth is the foundation for every other human growth. This makes the gospel so vital for change. The gospel transforms the perception of the poor from worthless failures to an appreciation that in Christ they have the same worth as other people. V. T. Rajshekar, a non-Christian leader of Dalits, suggests for the Dalits, "Poverty is not the number one problem. People cannot live by bread alone. They want the self-respect which is denied under Hinduism. They will get it the moment they get out of Hinduism and convert to other religions." ²⁹

Bishop Vedanayagam Samuel Azariah (1874-1945)³⁰, born into a Nadar Christian family, was a successful leader of grassroots movements of religious transformation in South India in the early twentieth century. Nadars occupied a middle position of "semi-untouchables" in the caste system between "Dalits" ³¹ and "Sudras." Like Dalits, they were barred from entering temples or courts of justice, and dress regulations forbade women from covering the upper parts of their bodies. They were forbidden the use of public wells and were required to stay 36 paces away from high-caste Brahmins. Their houses were limited to one storey. They were forbidden to carry umbrellas, to wear shoes or gold ornaments, or to milk cows, and

At baptism he was given the new name "Thomas Vedanayagam," which combined the surname of Welsh missionary John Thomas (1807-70) and Veda, meaning Bible, and nayagam, meaning "master" or "leader." Cf. Susan Billington Harper, *In the Shadow of the Mahatma, Bishop V.S. Azariah and the Travails of Christianity in British India* (Curzon Press Ltd, Richmond, Surrey, U.K. 2000) has meticulously researched the major events and the issues of Azariah's public life, and her work is indeed a primary source to understand the role of religion in modern Indian social and political life (hereafter as ISM).

The currently acceptable term "Dalit" is used in this article. Dalit is a self-designation by those groups who belong to the Panchama (or fifth) Varna outside the Hindu caste system. Some names, such as "Untouchables," Depressed Class, Schedule caste, Harijan, were invented by government or political leaders on behalf of the "untouchable" groups. Different names were usually devised to reduce the stigma associated with older designations or to unite several oppressed groups into one definable category for government benefits. Each term therefore carries potent political and historical connotations. See James Massey (ed.), *Indigenous People: Dalits* (ISPCK, Delhi 1994).

women were not allowed to carry pots on their hips. Unlike Dalits, many Nadars abstained from liquor and beef and disapproved of the remarriage of widows.

The Christian Church helped Nadar women gain the right to cover their upper bodies during the violent breast-cloth controversy of the early-to mid-nineteenth century. Nadar women were frequently attacked, stripped, and beaten, and chapels and schools were burned for the offence of wearing the breast cloths previously worn only by higher-caste Nair women. Empowered by the gospel teaching, Nadars became leaders in the movement for social change.³²

He studied theology from 1978 to 1982 at STH Basel (Switzerland) and since 1983 Cultural Anthropology and Comparative Religions at Bonn State University. He earned a Drs. theol. in Missiology and Ecumenics at Theological University (Kampen/Netherlands) in 1984, and a Dr. theol. in Missiology and Ecumenics at Johannes Calvin Foundation (Kampen/Netherlands) in 1985, a Ph.D. in Cultural Anthropology at Pacific Western University in Los Angeles (CA) in 1989, a Th.D. in Ethics at Whitefield Theological Seminary in Lakeland (FL) in 1996, and a Dr. phil. in Comparative Religions / Sociology of Religion at State University of Bonn in 2007.
